Dear Steve:

The South Carolina Dental Association (SCDA) is appreciative to the Department of Health and Human Services (DHHS) for the joint work we have done regarding the Medicaid Dental Program. We are looking forward to the meeting planned for January 24, 2014, to review the overall dental benefits for children and discuss the reimplementation of the adult program.

As we plan for the meeting in January, the SCDA would like to have a detailed discussion on a fee increase for the services provided. As you know, a few years ago, the dentists faced two 3% cuts along with the elimination of the emergency adult program.

The SCDA is in full support of bringing back the emergency dental adult program, and the possibility of adding preventive services for adults. Before that final decision is made, would it be possible for some of the money targeted for adult preventive services to be used for a fee increase in services provided for the children?

The SCDA is aware that pediatricians have received increases in their reimbursement rates recently and we strongly feel that an increase for the dentists is overdue, especially since there has not been one since 2000.

Although the current numbers may not reflect an access to care issue, and the current numbers may reflect more children being seen, the SCDA is very concerned about the future. We are beginning to hear from more and more dentists that they may no longer be able to afford to accept Medicaid or they are no longer accepting new Medicaid patients. This concerns the SCDA that an access to care problem may be looming in the near future.

The SCDA has and will be supportive of the Medicaid program, but we urge the DHHS to consider some type of fee increase that would be beneficial to all.

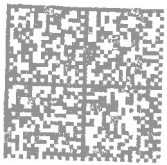
