SKIP: Per the other response I just sent, let's first see if anyone on this e-mail chain even responds -- and if so, with what comment or observation. If you are planning to pursue an "unfair business/competition" lawsuit, there must be a legal basis for it -- under either federal law, state law, or both. If you remember, I told you way back that I researched this with the FTC and was told that there is no federal law that prevents a Chamber or CVB from selling advertising. And all of them do, as we all know. Yes, the IRS 501(c)(6) code SEEMS to be violated, but as all of the six (c)(6) expert lawyers I talked to (including the deans of two major law schools) told me, as you know, "Good luck getting the IRS to go after such politically powerful organizations. It's never going to happen." Whether Dr. Joe and his team will succeed in that with their big-gun NYC law firms is an open question -- and based on our meeting, I share your confidence that it's possible. But that battle is going to take a long time and would result in the Chambers and VCBs owing back taxes and penalties -- NOT being "banned" from selling advertising. If you also remember, I spoke to several civil litigators in SC and they also said they know of no basis there for bringing an "unfair business/competition" lawsuit against the Chamber. Those kinds of actions, and the underlying laws that facilitate them -- just as at the federal level with the FTC -- are consumer-based, not business-to-business based. So again, in one simple sentence, on what basis do you think you can bring an "unfair business" lawsuit in SC and win?

I'm totally on your side, and everyone this is e-mail thread knows and understands that.

But we need a clear plan, not just your opinion.

Again, I hope someone on this thread will respond -- and prove me WRONG. I would like nothing better than that under the circumstances. Please note I have added Mike Alsko, Lee Edwards and Taylor Smith as CC recipients.
