Dear State Medicaid Directors,

As many states are transitioning their delivery systems to managed care models, our office is experiencing an increased volume of managed care actions. In an effort to streamline our process, we have created a centralized mailbox for the submittal of Medicaid managed care contracts to the Atlanta Regional Office.

Effective February 17, 2015, we request that all managed care contracts (including draft contracts), amendments, actuarial certification of rates, External Quality Review Organization (EQRO) contracts and amendments be submitted to the following CMS mailbox at ROATLMCD@cms.hhs.gov. This new process will ensure timely review and processing of contracts, amendments and certification of rates.

Please continue to copy the CMS Managed Care Analyst assignments to your state on these submittals. I have attached the CMS assignment list.
