

I'm just looking over some of the plans that were sent to me in an booklet 'medicare & you'. I have some major issues with a few things and thought I would run them by you.



my payment through blue cross blue ppo is \$45.00 a month; though not a lot, it irritates me that I am REQUIRED to pay for insurance that I have never used in 4 years. And on top of that looked at all the plans offered in South Carolina in the book --to find that IF you live in Charleston, Greenville or Beaufort--there are plans with zero \$....but Horry County is considered 'high risk' among insurance companies (exact words from SS representative)







Thank you for your letter regarding your constituent, Ms. Patty Blum, and her request for an explanation of the variable cost of Medicare Part D plans for Horry County residents as well as the requirement that she participate in a Medicare Part D plan. These are all Medicare issues and are subject to federal requirements.

Medicare's Open Enrollment period is October 15, 2012 through December 7, 2012. All individuals with Medicare can change their Medicare health plan and prescription drug coverage for 2013. Medicare members can call 1-800-MEDICARE or visit [www.medicare.gov](http://www.medicare.gov) for plan information. In this way, Ms. Blum can have her concerns addressed and change her health plan and prescription drug coverage for 2013 during the open enrollment period if she would like.

I appreciate your concern for this constituent, and trust you will find this information helpful. Thank you for your continued support of our Medicaid program and the citizens we serve.
