### Governor Nikki Haley News:

**Post and Courier:** Electrode maker Showa Denko Carbon to mark \$300 million expansion Friday in Dorchester County

A major Lowcountry industry will celebrate its \$300 million expansion Friday, nearly doubling its capacity to supply electrodes to the steel industry. Showa Denko Carbon near Ridgeville in Dorchester County will mark its expanded facilities with a ribbon-cutting ceremony at 10:30 a.m.

**Note:** Gov. Nikki Haley and company officials will attend.

**Note:** Showa Denko's ceremony comes two days after French high-voltage cablemaker Nexans snipped the ribbon on its new \$85 million facility in Berkeley County, where Haley also participated.

The Occupy Columbia case - in which protesters sued over their right to demonstrate on the Statehouse grounds - cost \$510,000 to defend and settle, with about two-thirds of that going to several law firms that defended the governor's office and the rest of state government.

**Note:** Haley said the protesters were free to return during daylight hours, but she noted that the occupation had damaged the Statehouse grounds and cost thousands in officer overtime and other costs.

About three-dozen gay and lesbian couples who dreamed of getting married in South Carolina saw their hopes dashed at least temporarily Thursday when the state Supreme Court ordered probate judges not to give licenses for same-sex marriages.

**Note:** And while Wilson, Gov. Nikki Haley and other South Carolina leaders have not been vitriolic in defending the gay marriage ban, Condon said they still broke hearts and made a number of people in their state again feel like second-class citizens.

The S.C. Supreme Court ruled Thursday it will maintain the state's status quo of not allowing same-sex marriage licenses in South Carolina until a U.S. District Court makes its ruling in a related Lexington County case. The court order also said the issue of the constitutionality of same-sex marriage in the state won't be considered by state courts while the issue is still pending in U.S. District Court here.

The South Carolina Supreme Court on Thursday morning directed all probate judges not to issue marriage licenses to same-sex couples until the state's federal lawsuit is decided.

**Note:** Haley said Wednesday that she thinks marriage only should be between a man and a woman, adding she took an oath to uphold the state Constitution, which bans same-sex unions. But she said the courts left



the issue a mess.

**Note:** "We have to figure out what that is right now," Haley said. "That's the big question of the day for everyone in South Carolina. Where does the rule of law stand after this and where does that leave South Carolina?"

South Carolina state officials won their request for a stay on gay marriages Thursday. Before noon, the South Carolina Supreme Court issued an order for the state to maintain "the status quo" pending a federal ruling in a gay marriage case.

**Note:** South Carolina Gov. Nikki Haley, who is a co-defendant with Mr. Wilson in the Bradacs lawsuit, said this week that her job is to "protect the Constitution" and "the Constitution says that marriage is defined between a man and a woman."

The South Carolina Supreme Court issued an injunction to stop a Charleston judge from issuing marriage licenses to same-sex couples. The court also directed all other probate judges to refrain from issuing marriage licenses to same-sex couples until a decision is made in a lawsuit pending in federal court.

Weddings, court rulings and confusion are defining a week that started with the U.S. Supreme Court denying appeals from five states seeking to retain their bans on same-sex marriage, followed by a ruling overturning some bans in Western states. Some states affected by the decisions are going ahead with weddings; some are proceeding toward marriage deliberately; and some are putting up a fight.

**Note:** The South Carolina Supreme Court ordered lower state courts not to issue same-sex marriage licenses until a federal judge decides whether the state constitution's ban on the unions is legal. The move came a day after a judge in Charleston had begun accepting applications.
