On 8-21-02, Danny Ray Hughey went to Gaffney Highway Department and was there for approx. 1 1/2 hours only to be told that he could not receive his License Tag for recently purchased Chevy Silverado. He spoke to Debbie Patton at the Gaffney Office & was told this couldn't be issued because Columbia had not okayed them to put what was needed into the computer to issue a tag. He left the Highway Dept. & called back on the 22nd & was told that Columbia office still had not done anything re: this.

Danny called the Columbia office & was told by Ms. Burgess that Gaffney had to issue the tag. They were supposed to email Gaffney & get the Gaffney office to issue this. Ms. Burgess told Danny they had 2-3 million of these to do. He explained to her that he needed to out of state & couldn't do so because of no tag, not wanting to be fined. He called the Gaffney Highway Dept. on 8-26-02 & spoke to Debbie again, who informed him that they still had not received anything from Columbia office. He spoke to Mike Howell's secretary in the Greenville office on 8-26-02 who informed him that she would call both Columbia & Gaffney to see if she could get this straightened out. On 8-27-02 he spoke to Ms. Gregory at Gaffney Highway Dept. & was told she had been contacted by Greenville, but still had not received the information needed from Columbia office to allow her to issue Danny a tag.
