We have been under martial law since 1861.

The U.S. of A. has been under 'Military Rule' (See Articles 3 & 8 of the Lieber Code) of 12 Statute 319 since August 9, 1861. This is the threshold authority for Obama's dictatorial powers. The Civil War Military enforced this upon civilians under General Orders 100 (Article 149 of the Lieber Code).
Researched by William Whiting, Solicitor General of the U.S. under Lincoln. Whiting on The War Powers of the President and the Legislative Powers of Congress in Relation to Rebellion, Treason, and Slavery' (Boston, 1862; 10th ed., with large additions, 1863; 43d ed., 1871). In this he formulated views that he had urged at the opening of the civil war, namely, that the United States government had full belligerent rights against the inhabitants of seceded states, and without going beyond the constitution could confiscate their property, emancipate their slaves, and treat them as public enemies. These opinions were at first received with caution by most public men, but they were finally sanctioned and adopted by the government. See also: 12 USC 95a; the 1917 Trading With the Enemy Act; The Banking Act of 1933 where the American People were made enemies of both the United States, Inc., and the Federal Reserve Corporation; 28 USC 2461-2465; and 50 USC 212-215. Thus Congress functions merely in an advisory capacity, pretending to legislate, as we have observed.

War Powers of the Executive Legitimate for Martial Law Dictatorship



Karen Hudes studied law at Yale Law School and economics at the University of Amsterdam. She worked in the US Export Import Bank of the US from 1980-1985 and in the Legal Department of the World Bank from 1986-2007. She established the Non Governmental Organization Committee of the International Law Section of the American Bar Association and the Committee on Multilateralism and the Accountability of International Organizations of the American Branch of the International Law Association. In 2007 Karen warned the US Treasury Department and US Congress that the US would lose its right to appoint the President of the World Bank if the current American President of the World Bank did not play by the rules. I have no ironclad proof about Scalia, as was also commented on the video I posted last night. What I have is Scalia's statement about Article V and my exposure of the legal profession's complicity :

You are not debunking any myths -- you are perpetuating them. The United States is currently in interregnum with no legitimate government. Article V is necessary to put the Constitution of 1789 back into effect.

Three days after I denounced Justice Scalia, the DC Bar, the American Bar Association, the International Law Association, and the rest of the legal profession for hiding the fact that Congress has been extending a state of emergency behind closed doors to justify secret martial law, Justice Scalia met with a mysterious sudden death.

My teleprompter was erased from my computer hours before yesterday's broadcast on the Network of Global Corporate Control Series in order to delete what Justice Scalia said about Article V:

The founders inserted this alternative method of obtaining constitutional amendments because they knew the Congress would be unwilling to give attention to many issues the people are concerned with, particularly those involving restrictions on the federal government's own power. The founders foresaw that and they provided the convention as a remedy. If the only way to get that convention is to take this minimal risk, then it is a reasonable one.

The US monetary gold reserves that Kennedy and Reagan accessed before they were gunned down are in the Global Debt Facility administered by the Board of Governors of the World Bank and IMF. On February 8, as Overseer Mandate Trustee of the Global Debt Facility, and on behalf of the Board of Governors (and approved by the Board of Governors), I replaced the US representatives on the Board of Governors and the Board of Executive Directors because they broke the Articles of the Bretton Woods institutions trying to steal the monetary gold reserves from the world's people.
