Juvenile Ty'Quan Edwards (#412345, Darlington, B/M, 15yo) and Juvenile Ronell Brown (#395616, Charleston, B/M, 14yo) were both transported to Richland Memorial Hospital by EMS escorted by DJJ Police/DJJ Investigations due to the juveniles allegedly consuming an unknown liquid at this time. The nurse states both juveniles "passed out" and had declining blood pressures. An update will be provided once the juveniles are assessed by a physician.
