The reason I'm writing again is I'm having difficulties and need help. I use to work 2-4jobs for 33years until lady hit me and I was pronounced dead and saw heaven. I have metal plates in my head after 3 blood clots drained off my head. I know God has a purpose and I believe He put me and my husband together for a reason. We first married April 2011 in Georgetown, SC and he has been incarnated since September 5, 2011. We have not even spent our 1st thanksgiving or Christmas together. It's been a bad trial. He got stabbed in eye in. 2011 by inmate that shouldn't have been at Jrueben long. My husband eye bleed 2 weeks without care. He needed surgery that kept getting put off and went blind. After all these years finally got eye surgery thank God. He filed PCR over a year ago against public defender Eric Fox who was originally out of Georgetown public defenders office who only went to see Larry 1 time who promised to get bond set and didn't. At court he didn't even know who Zlarry was. Larry tried to fire him twice before same judge and judge Hyman refused. Then Eric misrepresented him and was unprepared and refused witnesses which all our rights broken 4,5,6,7,&8 and illegal track device put on vehicles without proper procedure or consent. Also Larry in 2011 Filed for preliminary hearing and then filed fast& speedy trial and never got !!! Then in court pd Eric Fox talked Larry into. 0-5year non-Violant plea and misled him and Judge gave him. 30 years Violant. This was not right. Well now that Larry filed PCR over a year ago, I kept calling and his appointed PCR attorney Daniel Selwa his secretary Stella and she say daniel got on desk but hasn't had chance look over it and after he does he will make appointed. This went on over a year. I kept calling to see when PCR was and she tell me same thing. Well today Larry was took in shackles and people at wci asked where is your papers and he said what papers and they said court papers your PCR today and Larry said what I never have met my appointed PCR attorney. This is dirty and wrong. Attorney knew nothing from Larry and never met Larry to discuss anything about case. When Larry got to court today atty Daniel Selwa told Larry u don't have a foot to stand on and Larry said u never called my wife back nor never met with me. Do in court room daniel called Larry to the stand and Larry said your honor I want to dismiss this guy as council and judge said on what basis and Larry said he is not prepared and he never met with me nor returned my wife's calls and never informed me of court or gathered any info from me. And Daniel lied which is contempt of court and said he talked to me several times and said he tried set up appointment but that Larry was in Hilton Head. Larry said there is no prison in Hilton Head

and no your honor he never returned my wife's phone calls. So judge said I will give you atty Selwa more time to get accaanted. And Larry said well I appreciate that but I don't won't him to represent me I have a bad taste in my mouth like I did with Eric Fox who did nothing to help me and misled me. So judge appointed Larry another attorney and said you have to stick with this new attorney I'm appointed. Please Governor help us . Also conflict of interest Attorney Daniel Selwa I looked him up today and he and Public Defender Eric Fox use to work together so how could he go up against Eric this is misconduct and conflict of interest . Also Paul sheets was friends with Larry's ex wife who I wasn't with Zlarry when he was married and divorced her in. 2008 and Paul Sheets her friend broke in my trunk of my car without proper procedure. So much corrupt in Horry County court system between judges and solicitors and public defenders and my husband is still not treated fairly . My husband was suppose to go before a very nice judge and eric fox and solicitor Scott Hucks took Larry out court room. All our rights broken and my husband injured and we could have filed lawsuit but haven't yet . Please help and release my husband or ask parole to release my husband he was suppose to get. 0 -5 non - Violant and he has been locked up since September 5,2011. He is low level 1 with no write ups and I need him home. I have had man tried to break in on me and I have medical health issues ; PTSD , Traumatic Head Brain Injury , 2lt strokes , It heart attack and other issues. I need my husband to take me yo my doctors appointments . I get lost and have severe panic attacks to the pointe I can't breathe or catch my breath. What's scary is I'm alone and I have panic attacks in my sleep and wake up alone and can't catch my breath . Please I can't go thtu this stress how my husband is being RailRoaded and I can't get help. Everything is overwhelming Please do something , he is at Wateree Correctional in Rembert,SC . He is Larry Alan McDaniel (SCDC # 354216) it would be a nice thanksgiving for him to be home do we as honeymooners could have our 1st thanksging. God knows all our hearts and my husband is no threat to no one and deserves to be home.God Bless You, Lisa McDaniel
