### Governor Nikki Haley News:

**Post and Courier:** Lindsey Graham praises Haley on abortion ban bill, wishes rape and incest exceptions were included

Gov. Nikki Haley is facing criticism for signing a bill into law making it a crime for a woman to get an abortion after the 20-week threshold, with no exceptions for pregnancies resulting from rape or incest. U.S. Sen. Lindsey Graham, R-S.C., has been pushing a nearly identical bill on Capitol Hill to extend the ban across all states — except his proposal includes those exceptions. “I feel better with the exceptions,” Graham told The Post and Courier on Thursday, a day after Haley’s bill signing in Columbia. “That’s where I’ve always been on this issue.”

A House committee has been asked to determine whether a Department of Public Safety official lied to lawmakers and should face criminal charges. The subcommittee investigating the agency voted Thursday to ask the full House Legislative Oversight Committee to review comments made by Human Resources Director Tosha Autry. At the May 5 meeting, lawmakers played a tape of Autry saying there were times when it was OK to lie. She says the comment was misunderstood and she was saying human resources information workers sometimes can't tell everything they know.

The House has again passed a major overhaul of South Carolina's public records law to try and work around the objections of one senator. The proposal passed 93-1 on Thursday would shorten the amount of time governments have to answer Freedom of Information Act requests and prevent them from charging excessive fees. It also would create an agency to hear disputes between public bodies and people requesting information.

Legislators aren't spending any money next fiscal year to display the Confederate flag sent to a museum last summer as they await an analysis on moving the entire museum to Charleston. A legislative panel negotiating a final spending plan for 2016-17 approved a budget clause that requires an analysis of available museum space in Charleston and a cost estimate for moving the state's military history museum there. A report is due Jan. 10.

The House has rejected the Senate's changes in a bill that would require lawmakers and other public employees to report their income from private companies. The House passed two amendments to the Senate bill Thursday. One would require public officials to report the amount as well as the source of the income. The second would require nonprofit organizations to reveal who gives the money they spend on elections and other political campaigns. The Senate likely won't agree to those changes.

A legislative panel breathed new life into the possibility of regulations aimed at limiting dangerous demonstrations on Statehouse grounds following multiple protest arrests last year. The State House Committee received draft regulations Thursday. A major change would be to require a permitting process for Statehouse demonstrations. During that process, law enforcement agencies would give the Department of Administration input on whether to deny a permit if an event posed a public safety risk.

A federal judge has ruled that a regional economic development group can't be part of South Carolina's lawsuit against the U.S. Energy Department over an incomplete nuclear fuel project. U.S. District Judge Michelle Childs on Wednesday rejected the request by the Southern Carolina Regional Development Alliance, saying the nonprofit group doesn't have legal standing to intervene in the dispute between the state and federal governments. Childs also wrote that the group's participation in the case "would complicate the litigation, potentially unduly delay the adjudication of the case on the merits, and generate little, if any, corresponding benefit to the existing parties."

Republican U.S. Sen. Richard Burr told The Huffington Post that North Carolina's Republican lawmakers went too far when they passed House Bill 2, and need to rein it in before a judge does it for them. "It was far too expansive."

Five of the six Republicans in the S.C. congressional delegation joined with 125 GOP colleagues to sink an energy and water spending bill Thursday, irked by a provision barring the government from hiring federal contractors that discriminate against lesbians, gays, bisexuals and transgender individuals. U.S. Rep. Tom Rice, R-S.C., characterized it as a "religious liberty" issue in explaining part of the rationale for his "no" vote. U.S. Rep. Jeff Duncan, R-S.C., agreed. "I'm a believer in Jesus Christ as my savior," he recently explained. "I also believe in the First Amendment, religious liberty."

Leaders at South Carolina's Department of Juvenile Justice were slow to recognize problems that led to riots at its main prison but are taking decisive steps to regain control, the state inspector general said. Several issues over a few years combined to create bigger problems at the agency, according to the report Inspector General Patrick Maley presented to a joint committee of Senate and House members Thursday. There was a lack of serious punishment for misbehavior along with an increase in gang activity and a policy to move less violent offenders to wilderness camps, concentrating the most dangerous inmates at the agency's main Columbia prison.

Guards overseeing the state's youthful inmates said they felt in danger before recent riots at a Columbia facility, the state's watchdog told lawmakers Thursday. Those guards also felt like there were no consequences for bad behavior by youthful offenders at the Department of Juvenile Justice facility. S.C. Inspector General Patrick Maley also said guards were not adequately trained to deal with out-of-control inmates.

After three severe incidents at Department of Juvenile Justice facilities within an eight-month period, the South Carolina inspector general told a panel of legislators that poor execution of established plans led to a violent February riot. Inspector Patrick Maley said Thursday that DJJ officials established a plan after a September outbreak but that it had not been implemented and ready at the time of the February disturbance. "If they had executed that plan with the level they had executed it in March, I believe that would have been a success story," Maley said.

Committees from the House and Senate have been looking into the agency since multiple riots broke out at the Department's Broad River Road facility. The joint hearing was scheduled after a WACH FOX News investigation opened new details about a riot that took place on February 26th. South Carolina Inspector General Patrick Maley testified for nearly an hour, giving his thoughts on where the agency stands. The General has been doing his own investigation into several matters at DJJ.

State auditors are recommending that the Legislature either close the South Carolina agency that borrows and doles out money for large highway and bridge projects or make it part of the Department of Transportation. The S.C. Transportation Infrastructure bank should be consolidated under the state's main Transportation Department, according to an audit of the state agency released Thursday. "During our review, we found no function performed by (the Infrastructure Bank) that could not also be performed by discontinuing" the Infrastructure Bank and transferring its money to the Transportation Department, the S.C. Legislative Audit Council found.

A report by the Statehouse's investigative arm found the state Transportation Infrastructure Bank, which was behind the financing of the Arthur Ravenel Bridge Jr., would be better off merged with the state Department of Transportation. "During our review, we found no function performed by SCTIB that could not also be performed by discontinuing the SCTIB and transferring its funds to SCDOT," the Legislative Audit Council said Thursday. Since the bank's inception in 1997, its seven-member board has awarded \$4.8 billion in grants and loans, with more than \$1.4 billion sent to the Charleston tri-county area.

The state agency that has financed almost \$5 billion in transportation projects has awarded funds to projects without an application, has no formal policies for awarding funding, and does not announce publicly when it has funds available, according to a critical Legislative Audit Council report that suggests the agency be merged with the state's highway agency. The report comes as the Legislature is poised to approve a bill that could eventually result in the state borrowing more than \$2 billion through the State Transportation Infrastructure Bank.

Five Republicans running in contested races in the June primary have received the backing of a York County conservative group. The GPS Conservatives for Action PAC formally endorsed the five candidates via email this week, all but one a challenger to an incumbent or a candidate for an open seat. U.S. Rep. Mick Mulvaney, R-Indian Land, is the only incumbent to receive an endorsement from the group. Mulvaney, an congressman since he managed to knock off longtime incumbent John Spratt in the 5th Congressional District during the tea party wave of 2010, is facing a primary challenge June 14 from nonprofit coordinator Ray Craig.

The fate of \$420 million slated for the extension of Interstate 526 in Charleston County is unknown after the S.C. Transportation Infrastructure Bank approved Thursday winding down the project. The



board determined Charleston County did not meet a **deadline** to come up with a plan to pay \$300-plus million to extend I-526, also known as the Mark Clark project. When approved, in 2006, the \$420 million in state money would have paid the entire cost to extend I-526 across Johns Island. The interstate now ends in West Ashley.

The S.C. Transportation Infrastructure Bank board on Thursday dealt the biggest blow ever to plans for completing Interstate 526 across James and Johns islands, a decades-old project that deeply divided the community. The long-stalled project to connect I-526 from where it currently ends in West Ashley to where the James Island connector begins at Folly Road won't be built, at least not any time soon. After almost three hours of discussion about keeping the project alive by building it as a toll road, the board voted 4-1 to close the door on it. Only State Rep. Chip Limehouse, R-Charleston, voted against the motion.

The Southern Environmental Law Center on Thursday called for the State Ports Authority to move its proposed cruise ship terminal away from the city's Historic District and to Veterans Terminal in North Charleston — something the maritime agency says it can't do because of prohibitive costs and wharf damage that hasn't been repaired. Meanwhile, the environmental group is asking state Attorney General Alan Wilson to reconsider a formal opinion he issued this year saying the proposed terminal is exempt from the need for a state permit. The law center and historic preservation groups are suing the SPA over whether a previously issued state permit was properly granted, and the state's Court of Appeals is expected to hear the case this summer.

**Associated Press:** Delegates in hand, Trump says he's got GOP nomination

With a triumphant pile of delegates in hand, Republican Donald Trump on Thursday claimed support from "almost everybody" in his party and turned his attention to his likely Democratic presidential opponent, Hillary Clinton, who is still locked in a divisive primary contest. The New York billionaire reached the number of delegates needed to clinch the GOP nomination hours earlier, according to the Associated Press count, just before a North Dakota campaign stop. It completed his unlikely rise that has upended the political landscape and set the stage for a bitter fall campaign. "Here I am watching Hillary fight, and she can't close the deal," he told reporters. "We've had tremendous support from almost everybody."

John Trandem wanted to be the delegate who would put Donald Trump over the top, giving him enough delegates to clinch the Republican presidential nomination. But when he was contacted by an Associated Press reporter, the AP delegate count stood at 1,235 — two delegates short. "I'm happy to be No. 1,237," said Trandem, a small business owner from North Dakota. "But I won't commit until you're at 1,236." Trandem is an unbound delegate, meaning he is free to support the candidate of his choice. All 28 Republican delegates in North Dakota are unbound because the state party declined to have a primary or caucus.

Hillary Clinton contends a new government audit critical of her use of a private email server as secretary of state won't affect her Democratic presidential campaign. In an interview with Univision's Los Angeles affiliate, Clinton said "nothing has changed" following Wednesday's release of a report by the State Department's inspector general. That analysis found Clinton ignored clear guidance that her email setup broke agency rules and could have left government secrets vulnerable to hackers. "There may be reports that come out, but nothing has changed," Clinton said. "It's the same story. Just like previous secretaries of state, I used a personal email. Many people did. It was not at all unprecedented. I have turned over all my emails. No one else can say that."

**Associated Press:** Baylor demotes Starr, fires coach amid sex assaults scandal

Baylor University demoted school President Ken Starr and fired football coach Art Briles on Thursday, issuing a scathing report over the university's handling of sexual assault complaints against players. The board of regents at the nation's largest Baptist university said in a statement that Starr, a former prosecutor who investigated the Bill Clinton-Monica Lewinsky scandal, will vacate the presidency on May 31 and stay on as school chancellor. It said it suspended Briles "with intent to terminate" and placed athletic director Ian McCaw on probation. Starr asked a law firm last year to review Baylor's handling of sexual assault cases following allegations that the school mishandled several cases in which football players were accused of attacking women.
