Mr. Poore called the meeting to order and Councilman Wright gave the invocation.

Ms. Elaine Sherard presented County Council with a proposal from the Anderson County Committee on Supplemental Health Needs for a program that would require \$20,000 the first year. She furnished the Council with information regarding the request. Council received as information.

Mrs. Lila Albergotti commented on the 1980-81 proposed budget for Meals On Wheels. Council accepted Mrs. Albergotti's \$13,000 original request as information.

Mr. Ronnie Whitfield asked Council to consider the Youth Treatment Center for additional funding. He asked Council to consider his original request also for \$60,000. Council received as information.

Mr. Charlie Cole representing the Anderson County Arts Council asked that Council increase the Arts Council Budget to \$5,000 as originally requested. Council received Mr. Cole's comments as information.

Mr. Doyle Kay speaking for the Anderson County Alcohol and Drug Abuse Commission asked Council to fund the Detoxification Center/Half-Way House which would require \$10,000 in funds as originally requested. Council received as information.

Ms. Annie Ruth Morris commented on Account #580 Black History and Culture Center. She stated that the Deed to the property was on its way. She asked Council that any additional funding for the Foundation would be greatly appreciated. Council received as information.

Mr. Robert Wiles read a petition from Mr. Cecil Barksdale who was unable to be at the meeting. The people of Iva and workers of Iva Manufacturing Company request a road off 184 Southwest of Iva and running parallel with the factory and airport be considered for paving. The petition was signed by some 41 members. Mr. Poore advised Mr. Wiles that he would check into the matter and as soon as the 1980-81 Budget is passed making funds available he would repair the road.

Mr. Robert P. Lusk presented Ordinance #54 for West Pelzer Cable TV Franchise as amended. On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted unanimously to adopt on third and final reading.

Ms. Jean Taylor commented on the 1980-81 Budget for PATH, Inc. She asked Council to consider \$6,000 which is needed for operation.

Mr. David Watson, Assistant to Supervisor/Purchasing Agent, read Ordinance #56 (1980-81 FY Budget) for Council's approval (second reading). He stated that additional requests had been received. These requests included:

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to adopt Ordinance #56 (1980-81 FY Budget) on second reading with the supplements requested for consideration.
