Senator Martin,

The answers to your questions are below. I have also attached the CSID/SCDOR FAQs and Flyer Fact Sheet for your reference.

Q: What happens when someone is trying to enroll, but keeps getting an error message?

A: Katherine and I would be happy to talk to you about the specific error message you are referring to so that we can provide a more thorough answer. In general, if they are not able to resolve any error message online, they should contact CSID at 855-880-2743 to speak to a CSID specialist who can assist them.

Q: If someone hasn't filed a tax return electronically, are they not eligible?

What if they only mailed it in?

A: Individual taxpayers, their dependents, and businesses who filed electronic South Carolina tax returns between 1998 and 2012 may be eligible for CSID identity protection services. If they are not sure of their eligibility, they either go to [www.scidprotection.com](http://www.scidprotection.com) or call 855-880-2743 toll free to speak with a CSID specialist to determine eligibility and enroll.

Q: Are they prevented from enrolling?

A: For any person or business who cannot enroll online or by phone, CSID will refer their name to SCDOR. The Department of Revenue will review their records to make sure they are eligible for enrollment and then report the findings back to CSID. CSID will then contact them to either proceed with or deny enrollment.
