July 5, 1960

The State Budget and Control Board met in the office of the Governor at 11:00 A. M., on Tuesday, July 5. All members of the Board were present.

The Board fixed the compensation of the College Presidents as follows:

The Board agreed that no other expense allowances at the above institutions should be permitted as a part of any employee's compensation.

The Board approved the following salaries in the State Highway Department:

Chief Highway Commissioner	\$ 19,000.00

Asst. Chief Highway Commissioner	12,000.00

The Board agreed to an increase in the fee of the Retirement System New York Actuary from \$                      to \$                      .

The Board approved a request from the State Forester to permit the use of funds in the amount of \$20,000.00 to be realized from the sale of a portion of Camp Croft for further improvements in the Camp Croft Park.

The Board approved a budget as submitted by the State Forestry Commission for the year 1960-61 for scrub oak clearing and tree planting at State Parks. The total budget submitted amounted to \$130,180.00.

The Board declined to provide funds requested by the State Forestry Commission for operation of the Gist Historical Memorial in Union County for the fiscal year 1960-61.

The Board agreed to provide the Industrial Commission with the sum of \$4,500.00 for the year 1960-61 for the employment of an Assistant Claims Examiner.

The Board agreed to supply funds to the Department of Agriculture in the amount of \$5,600.00, for the year 1960-61, as salary and travel for an additional food inspector.

The Board agreed to rent necessary space for housing the Civil Defense Agency in the Federal Land Bank Building, the rent therefor not to exceed the sum of \$6,000.00 per annum.

The Board authorized the Director of Sinking Funds and Property to negotiate with the National Park Administration in connection with the returning to the Federal Government of a certain portion of the Fort Moultrie property.

The Board approved a loan to Lexington County School District No. 5 in the amount of \$12,000.00.

The Board approved a loan to Union County in the amount of \$60,000.00.

The Board approved a loan in the amount of \$175,000.00 to Union County School District.

The Board agreed to pay 1/2 of the cost incurred in the trial of more than 300 individuals in Orangeburg County charged with breach of peace in connection with "sit in" demonstrations, the remaining cost to be borne by Orangeburg County.

The Board approved the budget of the South Carolina Education Television Commission for operation during the fiscal year 1960-61 as submitted by the Commission.

The Board then adjourned.
