I have no idea how faithfully this draft reflects (1) the intent of the drafting attorneys and/or (2) the ultimate will of the conference committee, but if the final report were to resemble this, then here's the rough score. There are more bullet points under "bad" than "good" but I don't think the points are of equal value. The wins are generally the more important items...for now, anyway.

- Legislative Oversight - Effective date, 7 years (I think - they say 4 in some places, but I think it's an editing error), and no contempt felony. Doesn't have the 2/3 requirement for extra meetings, but that's the least important item anyway.
- Procurement Review Panel not currently tampered with
- DoA can reorganize itself (but likely conflicts with "governing authority" language below)
- Tobacco Settlement Revenue Management Authority doesn't go to SCRIA
- Inspector General stays independent
- OEPP language is in
- Procurement reforms are in

#### BAD

- Mandates SCEIS and Capitol Complex line item requests (I'm pretty sure I'm alone in caring about this)
- Approval of statewide policies
- Procurement felony
- Joint Strategic Technology Committee and biennial Statewide Strategic Technology Plan (former is much worse than latter)
- Governing Authority language
- SCRIA Board changed, plus money transferred there
