Policy Recommendations to Improve Military and Overseas Voting

States Lift Food Stamp and Welfare Bans for Drug Offenders

Since 1996, 18 states have lifted their bans on food stamp eligibility for felony drug offenders, 26 states have issued partial bans for offenders with certain types of felony convictions, and only six states have full bans for those with any record of a felony drug conviction. States also set eligibility policy for federal Temporary Assistance for Needy Families benefits, also known as TANF; twelve states have full bans on receiving monthly TANF cash benefits for those with felony drug convictions.

Supreme Court to Decide Another "One-Person, One-Vote" Case

On June 29, the U.S. Supreme Court held in *Arizona State Legislature v. Arizona Independent Redistricting Commission* that Arizona's redistricting commission could be solely responsible for congressional redistricting, noting that the state's voters adopted the commission to avoid partisan gerrymandering. The next day, the court agreed to decide *Harris v. Arizona Independent Redistricting Commission*, where the plaintiffs allege the commission engaged in partisan gerrymandering in state legislative redistricting that violated one-person, one-vote.
