### Governor Nikki Haley News:

**Times and Democrat:** SC development agency allowed to continue bonuses

South Carolina's economic development agency can continue its bonus program for employees, following approval Tuesday by the Budget and Control Board. The unanimous vote extends through 2016 an incentive pay program aimed at rewarding Commerce Department staff when the agency meets goals in capital investment, overall job creation and jobs added in rural counties. Eligible employees can earn a bonus of up to 10 percent of their salary. Commerce Secretary Bobby Hitt said the sales incentive pay plan helps recruit, retain and motivate staff.

**Note:** Gov. Nikki Haley, the board's chairwoman, applauded the program. "This really is so much of why we're getting jobs in rural South Carolina," she said.

Gov. Nikki Haley said Tuesday her husband will be home before Christmas, after spending most of 2013 deployed in Afghanistan. The Republican governor said she's excited about the impending return of Capt. Michael Haley, who left in January for a month of training in Indiana before heading overseas. She expects to be notified of his arrival between 24 to 48 hours in advance.

**Note:** "It's like having a baby. You know it's going to happen. You're just waiting 'til when," she said. "We're getting really close. It will definitely be before Christmas. We do know that."

South Carolina Gov. Nikki Haley said her husband is expected to come home before Christmas after a nearly year-long S.C. National Guard deployment to Afghanistan. "They said they were going to give us 24 to 48 hours notice," she said Tuesday. "It's like having a baby. You know it's going to happen, you're just waiting til when. We're getting close. Michael Haley, 43, is a captain in the guard serving with an agriculture-training group in Afghanistan. He is believed to be the first spouse of a sitting governor to deploy to a combat zone with the National Guard.

Two South Carolina leaders declined to say directly Tuesday if the state is submitting a bid for producing Boeing's 777X jet. Proposed incentive packages are due to the Chicago aircraft maker on Tuesday. More than a dozen states reportedly received requests from Boeing to bid on producing the airliner with several touting their interest. But don't count South Carolina, where Boeing already has a manufacturing plant and received \$570 million in incentives, among the braggars.

**Note:** "We are always in good talks with Boeing," Gov. Nikki Haley said. "If something gets sent in, you'll know about it."

A Democratic senator has pre-filed legislation to restore funding for a program vetoed by Gov. Nikki Haley that issues certificates of need for the creation or addition of hospitals or other health facilities in the state.

Sen. Joel Lourie, a Columbia Democrat who had called for Haley to order a special legislative session this summer to deal with the issue, said the law establishing the state's certificate of need program is still law but no funding exists to operate it.

Lawmakers in the state House and Senate can pre-file legislation today, one of two days each chamber's members may introduce bills before returning to Columbia in January. While most bills are not available yet, here's a preview of what some lawmakers are introducing.

**Note:** Gov. Nikki Haley vetoed funding for the S.C. Department of Health and Environmental Control's Certificate of Need program earlier this year. Then DHEC chief Catherine Templeton decided that without money to pay for the program, DHEC would not enforce it. In response, hospitals and nursing homes are suing DHEC in the state Supreme Court.

A South Carolina Republican lawmaker is introducing his own plan for performance-based pay, even though dozens of schools are already testing Superintendent Mick Zais' proposal for evaluating educators. Rep. Andy Patrick, R-Hilton Head Island, said he's pre-filing a bill for the upcoming legislative session that's aimed at rewarding excellent teachers and providing others targeted training. Tuesday is the last day for

House members to pre-file bills for 2014. Senators have another week. Evaluating educators based on performance is a required part of the state's exemption from the all-or-nothing provisions of the federal No Child Left Behind law.

All statewide elected officers would have to comply if the measure passes -- governor, lieutenant governor, attorney general, treasurer, comptroller general, secretary of state, education superintendent, agriculture commissioner and adjutant general.

A hearing that supporters say could exonerate a 14-year-old boy executed in 1944 for the killings of two girls will likely take place in the next month, a prosecutor said Tuesday. Solicitor Ernest A. "Chip" Finney III came to a rally by civil rights groups who want to keep pressure on officials to clear George Stinney of all charges in the deaths of two girls in Clarendon County. Finney told the crowd he has no evidence to argue against a new trial for Stinney. The trial has been requested by a law firm working on behalf of Stinney's supporters. If a judge agrees, Finney said his office will have to review whatever evidence they can find in the 69-year-old case.

The man wanted in connection with last Friday's slaying of the brother-in-law of Columbia's mayor was arrested Tuesday morning, Charlotte-Mecklenburg Police say. Arthur Givens, 40, was taken into custody without incident at a residence on Echodale Drive, off Nations Ford Road in southwest Charlotte, according to police. Investigators say Givens is charged with murder, possession of a firearm by a felon, assault with a deadly weapon and communicating threats, according to police. Gist, 38, was shot and killed Friday afternoon in the 2100 block of Beatties Ford Road near LaSalle Street in northwest Charlotte. He is the brother-in-law of Columbia Mayor Steve Benjamin.

Local tax revenue collections for Oconee County schools fell more than \$630,000 short of projections last year, but state revenue more than covered the loss, according to Oconee school officials. Michael Thorsland, assistant district superintendent, said this week that in some recent years the collections had surpassed projections, sometimes by as much as "seven figures." The 2012-13 budget year, however, fell short. The figures were among those revealed Monday in the audit report of the 2012-13 school year, given by Don Estep, of the Seneca accounting firm of Stancil Cooley Estep and Stamey.

Charleston County sheriff's deputies are re-checking the status of nearly 29,000 unserved warrants for potential errors after discovering a mistake that helped a sexual assault suspect avoid arrest for 16 years. Assistant Sheriff Mitch Lucas said a team auditing the 28,604 warrants on file at the sheriff's office has discovered 26 warrants for serious felonies, including murder, that were not properly entered into a national database. A team of seven deputies has been assigned to try to track down those wanted suspects, Lucas said.

**McClatchy DC:** White House calls in help as Obama ratings tank

The White House is calling in a longtime Democratic strategist and former chief of staff for President Bill Clinton as President Obama grapples with the worst ratings of his presidency. John Podesta, the founder and former president of the Center for American Progress, has agreed to come aboard for a year, a source familiar with the talks said. Press Secretary Jay Carney said Podesta would be joining as a counselor to Obama, noting that Podesta has already served as an informal advisor to Obama and his chief of staff, Denis McDonough. Carney said Podesta will advise Obama "on a range of issues," with a focus on energy and climate change.
