This is from the Bureau of Labor Statistics, Current Employment Statistics program. It measures employment at the business level, so is a good measure of a jobs count. These numbers are a little different from the local area unemployment statistics programs, which surveys residents instead of businesses. The main distinction is that with the data below, if a person is employed in two firms, they

will show up twice. Thus, it is the best measure of jobs and not of total employment. More info is here: <http://www.bls.gov/sae/790faq2.htm#Ques3> This is annual average data.
