The recent thousand-year flood has left an estimated 727 South Carolina families without their homes, some due to insufficient resources to make necessary repairs. That is why our state established the One SC Fund through Central Carolina Community Foundation, a 501(c)(3) non-profit organization serving South Carolina since 1984. Several South Carolina celebrities and leaders have joined this effort, including former Governor David Beasley, Tajh Boyd, Stephen Colbert, Jay Haas, Marcus Lattimore, Edwin McCain, Bob McNair, Craig Melvin, Chris Randolph, Jerry Richardson, Mayor Joe Riley, Darius Rucker, Steve Spurrier, Dawn Staley, Dabo Swinney, and Anita Zucker. The goal of One SC is simple: It will help bridge the gap between existing resources and the unmet housing needs of flood victims. One SC will support nonprofit organizations that are providing relief and recovery efforts to these victims.

In order to assist in receiving donations to the fund, Governor Nikki Haley would like to establish One SC Fund as a charitable payroll deduction for state employees. The names of a minimum of 200 interested employees must be provided in order to obtain authorization for the payroll deduction. I am asking your assistance in disseminating this information to employees within your agency and for you to please send a compiled list of the names and PERNS of those employees who wish to contribute to this charitable organization.
