

South Carolina has one of the highest rates of domestic violence in the country. In fact, South Carolina currently ranks first in the nation for the rate of women murdered by men, ranking in the top ten for the past fifteen years.

In 2015, Gov. Nikki R. Haley created a Domestic Violence Task Force to make recommendations to address the cultural issues surrounding domestic violence. Richele Taylor, chair of the Community Awareness, Education and Outreach Division of the task force, and Farrar Stewart will update you on current actions taken by the task force and educate you on resources available to management and employees.
