## Medicaid & CHIP: November 2015 Monthly Report

The Centers for Medicare & Medicaid Services (CMS) released their monthly report for November 2015 on Medicaid and CHIP application, eligibility, and enrollment data. States provide data to CMS on factors related to key application, eligibility, and enrollment processes using the Medicaid and CHIP Performance Indicator Project. The data is then used to inform CMS on the operations of the programs in each state and to share state performance data publicly. The publication specifically brings attention to funding sources that states can use to help adult high-cost/high-need residents live.

## **Data Book: Beneficiaries Dually Eligible for Medicare and Medicaid**

The Medicaid and CHIP Payment and Access Commission (MACPAC) and the Medicare Payment Advisory Commission (MedPAC) released a data book that presents information of dual-eligible beneficiaries. The information includes demographics, other personal characteristics, expenditure, and health care utilization of the dual-eligibles. This data book is the third in a series that serves to create a better understanding of this population and how they tend to use available services.

### **Centers for Medicare & Medicaid Services**

#### **CMS Issues Home Health Final Rule**

On Wednesday, January 27, The Centers for Medicare & Medicaid Services (CMS) issued a final rule on Medicaid home health services. The final rule updated the definition of Medicaid home health services to include requirements that include medical supplies, equipment, and appliances. The new definition is consistent with section 6407 of the Patient Protection and Affordable Care Act of 2010 (the Affordable Care Act) and section 504 of the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). The rule will become effective on July 1, 2016.

#### **Office of Minority Health Releases New Guide to Preventing Readmission**

On January 26, the Centers for Medicare & Medicaid Services Office of Minority Health (CMS OMH) released a new guide titled *Guide to Preventing Readmissions Among Racially and Ethnically Diverse Medicare Beneficiaries*. The guide offers steps for minority beneficiaries to seek solutions that offer health equity and reduce readmission. Included in the guide are action-oriented steps, a set of seven key recommendations for hospital leaders, and concrete examples of initiatives and strategies.

#### **Informational Bulletin on Alternative Benefit Plan Conforming Changes**

The Centers for Medicare & Medicaid Services (CMS) released an informational bulletin about the alternative benefit plan conforming changes. The bulletin provides information to states about the regulatory changes in Essential Health Benefit (EHB) standards affecting Medicaid Alternative Benefit Plans (ABPs). Additionally, the state-required actions are included with

information about state plan amendment (SPA) submissions and ABP public notice requirements.

## Center for Disease Control and Prevention

### **CDC Releases New Elder Abuse Publication**

The Centers for Disease Control and Prevention (CDC), in collaboration with a group of elder abuse experts, released a new publication, *Elder Abuse Surveillance: Uniform Definitions and Recommended Core Data Elements*. There is no consistent definition of elder abuse or neglect, which makes comparing data from different states and regions very challenging. This paper serves to establish consistent definitions and data elements to make comparing data easier.

The recommendations were created with regard to ACL's [National Adult Maltreatment Reporting System \(NAMRS\)](#).

## The National Council on Disability

### **NCD Releases Report on Affordable Care Act for People with Disabilities**

The National Council on Disability (NCD) released a new report on implementation of the Affordable Care Act (ACA) and disabilities. This is the first of three reports on the subject. While the Affordable Care Act is a significant piece of legislation, people with disabilities were largely left outside of the policy conversation. This report is meant to serve as a "roadmap" for people with disabilities to show how it will affect them depending on how it is implemented. Structurally, the roadmap is organized chronologically and includes an analytic supplement that discusses policy options.

In *Guiding Principles for Sustainability of Age-Friendly Communities*, a framework with five core principles describes strategies and tools useful in this endeavor. The core sustainability principles are 1) building public will; 2) engaging across sectors; 3) utilizing metrics; 4) securing resources; and 5) advancing age-friendly public policies, practice and funding. The [National Core Indicators-Aging and Disabilities](#) tool is highlighted as one way that state and local programs can measure the performance of age-friendly work in order to provide meaningful metrics to demonstrate the need for and impact of age-friendly programs.

# Funding Opportunities

## Supportive Services Demonstration for Elderly Households in HUD-Assisted Multifamily Housing

The U.S. Department of Housing and Urban Development (HUD) announced it is making approximately \$15 million available to test a promising housing and services model for low-income seniors to age in their own homes and delay or avoid the need for nursing home care.

HUD's Supportive Services Demonstration for Elderly Households in HUD-Assisted Multifamily Housing will offer three-year grants to eligible owners of HUD-assisted senior housing developments to cover the cost of a full-time Enhanced Service Coordinator and a part-time Wellness Nurse. The purpose of the Demonstration is to test the effectiveness of this enhanced supportive services model for elderly households and to evaluate the value of enhanced service coordination paired with affordable housing for seniors. The demonstration will be independently evaluated to determine the impact of the enhanced supportive services model on: Aging in place in HUD-assisted senior developments; avoiding early transitions to institutional care, and; preventing unnecessary and often costly health care events-such as some emergency room visits and hospitalizations-for residents in HUD-assisted senior developments. Grant applications must be submitted electronically by **Monday, April 18, 2016, at 11:59 p.m. ET.**

## Inclusive Planning Impact Grant

The Transit Planning for All project has announced the availability of funding for community-based demonstration programs. The purpose of this funding opportunity is to encourage development of an inclusive coordinated transportation system in which people with disabilities and older adults actively participate in both advisory and decision-making capacities. While the intention is first and foremost the development of inclusionary processes and plans, the secondary expectation is that inclusion will result in identifiable and measurable changes in the transportation system that respond to the needs and preferences of older adults and people with disabilities.

To take advantage of this funding opportunity, communities should download both the request for proposals and the grant application form. All requirements stated in the application form must be met in order for an application to be considered. ## CMS Accountable Health Communities Grant

The U.S. Department of Health and Human Services, Centers for Medicare & Medicaid Services, and the Center for Medicare & Medicaid Innovation released a request for proposal (RFP) for an Affordable Care Act (ACA) funding opportunity for Accountable Health Communities (AHC), funding opportunity number CMS-1P1-17-001. The AHC model will test three community-focused interventions of varying intensity and their ability to impact total health care costs and inpatient and outpatient health care utilization. There are different tracks-Increase Awareness, Provide Assistance, and Align Partners-with varying funding amounts available. Each track will run for a five year period. A letter of intent to apply is required and due by Monday, February 8, 2016. An electronic cooperative agreement application is due by **1:00 p.m. ET on Thursday, March 31, 2016.**

## State Health Insurance Assistance Program (SHIP) Base Grant

The Administration for Community Living released the application for the the 2016 State Health Insurance Assistance Program (SHIP) Base Grant Funding Opportunity. Congress created the SHIP in 1990 with the goal of assisting Medicare-eligible individuals, their families, and their caregivers to make informed health insurance choices. There are currently 54 active SHIP grants; one in every state, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands. The funds awarded through this application are for the FY 2016 budget period, April 1, 2016 - March 31, 2017. Eligible applicants are states and United States territories that demonstrate their ability to provide the program through the state office of insurance, the state Medicaid office, or the department on aging. All applications must be submitted by **Monday, February 15, 2016, at 11:59 p.m. ET.**

## Enhanced Training & Services to End Abuse in Later Life Program Grant

The Office on Violence Against Women (OVW) has released the Fiscal Year 2016 Enhanced Training and Services to End Abuse in Later Life Program solicitation. The program provides three year awards for up to a total of \$400,000 to local communities to address abuse in later life, including domestic violence, dating violence, sexual assault, stalking, exploitation, and neglect against victims who are 50 years of age or older. Award funds must be used to organize training and cross-training for criminal justice and other professionals, develop services for older victims, and create or enhance a coordinated community response. All applications must be submitted by **Thursday, February 11, 2016, at 11:59 p.m. ET.**
