The Senate's judiciary chairman is pledging to hold a hearing this summer on legislation extending the allowed time for background checks on gun sales. Sen. Larry Martin's promise Thursday followed a rally outside the Statehouse against gun violence. More than 100 people called on legislators to pass laws that prevent criminals from getting guns. They held on to ribbons and posters to form a link and attempted to circle the Statehouse.

Horry County taxpayers don't know much more about the unexpected early retirement of the police chief than we did two weeks ago. Questions remain as to why? From information released last week, under a Freedom of Information Act request, we know Horry County is paying \$60,000-plus to the South Carolina Retirement System to make Sandra Rhodes eligible for retirement. Rhodes worked in the county police department for more than 23 years, rising to the top position four years ago. Her retirement announcement in late April was unexpected, and she alluded to looking forward to other employment although she was not specific about that being in law enforcement.

In the past year, debates such as this have bubbled in town meetings across the country. Mostly, discussions are related to Civil War monuments — in Louisiana, Maryland, Virginia and Texas — following the 2015 mass shooting at a historically black church in Charleston, S.C. But sometimes the discussion is broader: Last fall a cohort of Princeton students lobbied the administration to remove likenesses of Woodrow Wilson from the school's campus because of his segregationist beliefs. And last month, Andrew Jackson was toppled by Harriet Tubman off the front of the \$20 bill; supporters of the swap cited, among other reasons, Jackson's wretched treatment of American Indians. The problem is not going away. America has a lot of statues.

Trump and Ryan issued a statement describing their meeting as a "very positive step toward unification" that recognized "many important areas of common ground" as well as areas where they disagree. Ryan stunned Republicans by withholding his endorsement a week ago when it became clear Trump was on a firm path to the nomination.

Prosecutors say Edward Nero, whose trial in the arrest and subsequent death of Freddie Gray began Thursday, failed in his duty when he and other officers unlawfully arrested Gray, then neglected to buckle the shackled man's seat belt. But defense attorney Marc Zayon told Baltimore Circuit Judge Barry Williams that Nero, a volunteer firefighter with a passion for helping others, was justified when he chased Gray through West Baltimore because there was probable cause, as well as a directive from the State's Attorney's Office to be bullish about patrolling that particular area.

Brazil's suspended President Dilma Rousseff vowed Thursday to use "all legal means" to fight permanent ouster in an impeachment trial, raising the specter of continued political turmoil as interim leader Michel Temer tries to rescue a sinking economy. Speaking hours after the Senate voted to impeach her, in what might prove her last official event within the presidential palace, the nation's first female president blasted the process as "fraudulent" and said it was an injustice more painful than the torture she endured under a past military dictatorship.
