SC Child Support Enforcement



I am sending this fax that includes a print out from the SC Sex Offender Registry List (http://www.communitynotification.com/cap_main.php?office=54575). I contacted the SC Child Support Phone Line today and was dismayed when I spoke with Felicia, a representative and she informed me that no court date had been set yet do to SC Child Support Enforcement "can't find him". This is a case that has been open for over 7 years and he has resided in that state for the entire time. Because I am a resident of NC should have no bearing on the ability to locate a registered sex offender. I have provided this information on NUMEROUS occasions over the years to both NC Child Support Enforcement and to SC Child Support Enforcement. So understand my confusion and heaps of frustration at the inability to have this case enforced. I have attempted myself to take liens against his property (note the three vehicles/motorcycles on the registry list) and was told that SC Child Support is the one who must act upon it. I've waited to see if his license would be revoked, not to date. Or if he would go to jail, but I see now that it's impossible for the agency to run a check and find him anywhere since he's only listed on the Sex Offender Registry.

So once more I am providing you with this information, if you feel you need to verify it, please contact Renee at the Horry Co. Sheriff's Department 843-915-8573, I know if you look in the record, the previous contact was Sgt Lori Avant. In the past the Horry County Sheriff's Sex Offender Unit staff was more than agreeable to provide any verification you needed, and Renee has expressed the same desire to help. Please do not hesitate to contact them and verify or go to the link listed above. Perhaps then you will be able to "find him" and provide the enforcement that I have been asking for.

I do understand that your caseloads can be overwhelming, I have worked in a very similar environment, but at no point in time did I forget that each case had a name and a face. This case has a child attached to it and because it appears I cannot get persons to do their job, he faces a bleak Christmas. So thank you once again and if there is ANYTHING you need, please do not hesitate to ask. I am available for questions, comments, concerns.
