SECTION 12: On motion of Commissioner Jones, seconded by Commissioner Mullinax, the Commission unanimously passed a motion authorizing the staff to proceed with the development of an agreement with York County to implement a plan to accelerate the SC Route 161 project and to make recommendation to Commission for final approval.

SECTION 13: On motion of Commissioner Jones, seconded by Commissioner Goodstein, the Commission unanimously passed a motion authorizing the staff to review the proposal of Marlboro County regarding the four-laning of Highway 38 and report back to the Commission for action.



SECTION 14: Commissioner Whitehead made the following motion:

"I move that the Commission approve the Intergovernmental Agreement between Beaufort County and the Department regarding accelerating the widening of SC Route 170 and authorize the Director to execute the Intergovernmental Agreement on behalf of the Department."

Motion was seconded by Commissioner Jones and passed unanimously.

SECTION 15: On motion of Commissioner Whitehead, seconded by Commissioner Self, the Commission unanimously passed a motion adopting the following Resolution:

### **RESOLUTION**

**WHEREAS**, the South Carolina Department of Transportation ("SCDOT"), an agency of the State of South Carolina, owns, operates and maintains certain roads located in Beaufort County, South Carolina; and

**WHEREAS**, Beaufort County, a political subdivision of the State of South Carolina, has certain duties and responsibilities with respect to the provision of services within its boundaries; and

**WHEREAS**, SCDOT and Beaufort County recognize a need to widen the entire corridor of SC Route 170 between its intersection with US Route 278 at McGarvey's Corner to the City of Beaufort near the intersection with SC Route 280 consisting of 17.94 miles; and

**WHEREAS**, SCDOT has included the widening of a portion of the above identified 17.94 miles of SC Route 170 in its currently approved 1996 State Transportation Implementation Plan ("STIP") which contains allocation of projected Federal funding to be received from the Federal Highway Administration ("FHWA") during Federal fiscal years 1995 through 2000, commencing October 1, 1995; and

**WHEREAS**, State and Federal laws and regulations, including but not limited to the Federal Intermodal Surface Transportation Efficiency Act of 1991 (hereinafter "ISTEA") and the sales and use tax provision codified at SC CODE ANN. S4-37-10, et seq. (1976, as amended), make possible innovative financing arrangements for certain projects, but also impose limits and conditions on the manner in which a project may be carried out; and

**WHEREAS**, SCDOT and Beaufort County desire to take advantage of certain innovative financing arrangement and opportunities available under State and Federal law to expedite the upgrade and improvement of the 17.94 miles of SC Route 170 referenced above; and

**WHEREAS**, the people of Beaufort County will have submitted to them a referendum to approve a one percent (1%) sales and use tax in order to generate up to One Hundred Two Million Dollars (\$102,000,000.00) to supplement available STIP funding as necessary to accelerate the widening of the 17.94 miles of SC Route 170 from its intersection with US Route 278 at McGarvey's Corner to the City of Beaufort near SC Route 280 (the "Project").

**NOW, THEREFORE, IT IS HEREBY RESOLVED** that the SCDOT Commission intends to provide up to Ten Million Dollars (\$10,000,000.00) in Fallback State Highway Bond Financing should the total cost of the Project exceed the sum of the sales tax revenue and the SCDOT funding as provided by the current STIP. Should the use of this fallback financial support be triggered, the annual debt service incurred by SCDOT will be deducted from the annual amount due to Beaufort County until all debt service is satisfied. In such a case, the number of years will be increased to accomplish reimbursement to Beaufort County in accordance with the provisions of an Intergovernmental Agreement to be entered by and between Beaufort County and SCDOT.

SECTION 18: On motion of Commissioner Goodstein, seconded by Commissioner Whitehead, the Commission unanimously passed a motion directing the staff to prepare a resolution commending Special Investigator Tad Reed for his quick action during an incident in Summerville.

SECTION 19: There being no further business to come before the Commission, the meeting was adjourned at 1:10.

## SURPLUS RIGHT OF WAY PROPERTY - LAND

### 1. File 22.521 - U. S. Route 17 - Georgetown County

Under File 22.334, the Department added U. S. Route 521 in Georgetown County to the State Highway System by a letter dated May 26, 1958, from the City of Georgetown.

At the request of an adjoining owner, an investigation was made and it was determined by our Legal Section that the Department could relinquish a portion of the right of way located on the southern side of Fraser Street or U. S. Route 17. This action would clear an inadvertent encroachment on the Department's right of way and allow the owner to clear his own title. Therefore, a gratis quitclaim deed to Barbara W. Grayson and W. O. Grayson, Sr. was executed on May 31, 1996.

### 2. File 7.546 - SC Route 170 & U. S. Route 278 - Beaufort County

During acquisition of right of way for construction of improvements along SC Route 170 & U. S. Route 278 in Beaufort County, the Department acquired right of way from Union Camp Corporation by Title to Real Estate dated November 8, 1989, under File 7.546.

At the request of an adjoining owner, an investigation was made by our District Engineering Office and it was determined that a portion of the right of way was no longer needed and could be relinquished; particularly since the requester made concessions to the Department during negotiations for acquisitions. Therefore, a quitclaim deed conveying approximately 0.34 of an acre of land to The Branigar Organization, Inc. was executed on June 4, 1996, for consideration of \$3,000.00.

### 3. File 23.944 - Road S-107 - Greenville County

During acquisition of right of way for construction of improvements along Road S-107 in Greenville County, the Department acquired right of way from Henry A. Smith by Title to Real Estate dated October 9, 1984, under File 23.944.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the right of way was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately 3,225 square feet of land to Greerco Partners was executed on June 11, 1996, for consideration of \$1,615.00.

4. File 10.655 - Road S-1687 - Charleston County

Under File 10.655, the Department acquired a twenty foot ditch right of way along Road S-1687 in Charleston County from Bernard Fielding by Condemnation Notice dated February 18, 1971.

At the request of an adjoining owner, an investigation was made by the Charleston Maintenance Office and it was discovered that the ditch had been relocated and is no longer within our right of way. Therefore, a gratis quitclaim deed conveying the ditch right of way being approximately 0.03 of an acre of land to Bernard Fielding was executed on June 20, 1996.

5. File 23.248A - Road S-492 - Greenville County

During acquisition of right of way for construction of improvements along Road S-492 [now known as Road S-164 (New Batesville Road)] in Greenville County, the Department acquired right of way from Pelham Falls Venture by Condemnation Notice dated February 15, 1995, under File 23.248A.

During negotiations with an adjacent landowner while acquiring right of way, an agreement was reached that the Department could convey a portion of the above right of way. Therefore, a gratis quitclaim deed conveying approximately 472.5 square feet of land to Pelham Falls Venture was executed on June 20, 1996.

6. WPGH 146 - U. S. Route 21 - Lexington County

During acquisition of right of way for construction of U. S. Route 21 in Lexington County, the Department acquired right of way from R. L. King by Condemnation Notice dated July 23, 1937, under WPGH Project Number 146.

At the request of an adjoining property owner, an investigation was made by our District Engineering Office and it was determined that the Department could relinquish a portion of excess right of way along U. S. Route 21. Therefore, a gratis quitclaim deed conveying approximately 350 square feet of land to Charles R. Lee was executed on June 21, 1996.

7. File 33.359.4 - SC Route 28 - McCormick County

Under Project Number 744A, the Department acquired right of way for construction of SC Route 28 in McCormick County from Mrs. Mamie McDaniel by Deed to Right of Way dated July 18, 1930.

At the request of an adjoining owner, an investigation was made and it was determined that the Department could relinquish a portion of the abandoned right of way for Old SC Route 28, in consideration that the Department was granted the new location for Route 28. Therefore, a gratis quitclaim deed conveying approximately 0.86 of an acre of land to Juliette M. Oliphant was executed on July 9, 1996.

8. File 24.225 - SC Route 248 - Greenwood County

During acquisition of right of way for construction of improvements along SC Route 246 in Greenwood County, the Department acquired right of way from the Town of Ninety Six by Right of Way Easement dated February 13, 1941, under File 24.225.

At the request of the Town of Ninety Six for use as a public green area, an investigation was made by our District Engineering Office and it was determined that the Department could relinquish a portion of the excess right of way located on the western side of SC Route 246 in the Town of Ninety Six. Therefore, a gratis quitclaim deed conveying approximately 0.2 of an acre of land to the Town of Ninety Six was executed on July 1, 1996.

9. File 23.176A - Road S-510 - Greenville County

Under File 23.436 (Route I-385), the Department added Road S-510 in Greenville County to the State Highway System by Municipal Agreement dated September 23, 1959, from the City of Greenville.

During negotiations with an adjacent landowner for the new right of way, an agreement was reached that the Department would convey a portion of the abandoned old right of way for Old Congaree Road to the present owner of the adjacent property upon completion of the project. Therefore, a gratis quitclaim deed conveying approximately 0.37 of an acre of land to the Greenville Airport Commission was executed on July 1, 1996.

10. File 23.246A - Route I-85 - Greenville County

Under File 23.246A, the Department acquired right of way for construction of improvements for Route I-85 along U. S. Route 25 Business Relocation in Greenville County from Belton O'Neill, Jr. by Title Real Estate dated September 9, 1993; Joseph T. Moon by Condemnation Notice dated July 8, 1993; and Honey Properties by Condemnation Notice dated April 7, 1994.

During negotiations by our Legal Section with an adjacent landowner, an agreement was reached that the Department would convey the frontage/access road leading from Augusta Road (Route 25) into the property owned by Honey Properties. Therefore, a gratis quitclaim deed conveying approximately 0.811 of an acre of land to Honey Properties, Inc. was executed on July 12, 1996.

11. File 37.606 - U. S. Route 76/123 - Oconee County

During acquisition of right of way for construction of U. S. Route 76/123 in Oconee County, the Department acquired right of way from Annuity Board of the Southern Baptist Convention by Right of Way Easement dated September 13, 1963, and Dunlop Tire and Rubber Corporation by Right of Way Easement dated September 13, 1963, under File 37.448.

At the request of an adjoining property owner to realign the right of way adjoining their property, an investigation was made by our District Engineering Office and it was determined that the Department could relinquish a portion of right of way located along the southern side of U. S. Route 123. Therefore, a quitclaim deed conveying approximately 1.12 acres of land to Dunlop Maxfli Sports Corporation was executed on July 12, 1996, for consideration of \$8,280.00.

This matter is reported to the Commission in accordance with the requirements of Code Section 57-5-340.
