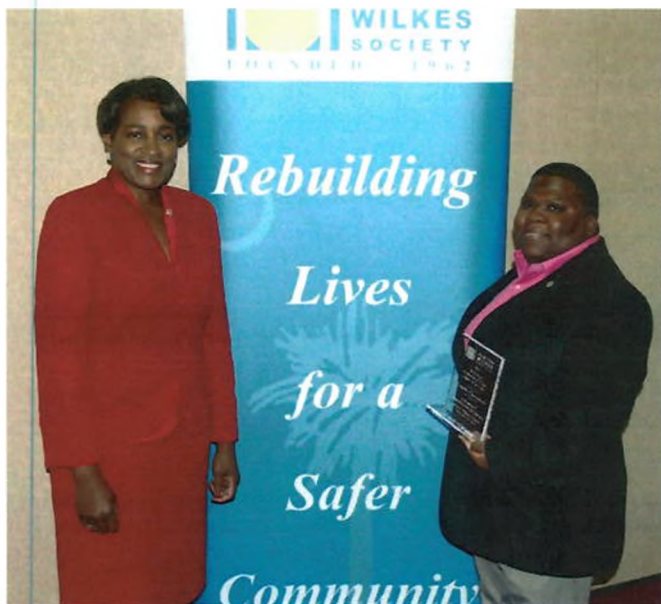
Debbie Dickerson

Alston Wilkes Names Cheeseboro as 2013 Mark Hart Award Winner

SCDPPPS Participate in Five Points Deployment
