Spotlight: S.C.'s Thriving Industries

South Carolina has established itself as a leader in the manufacturing renaissance, bringing more than \$12 billion in capital investment and more than 31,000 jobs in the sector in the last three and a half years alone. While the state continues its manufacturing stronghold, the Palmetto State's momentum in other key sectors - like corporate headquarters, logistics and technology - is on the rise as well.

Since 2011, the state has announced more than \$400 million in capital investment and more than 2,600 jobs in the agribusiness sector. Office space, headquarters and research and development (R&D) announcements have infused approximately \$900 million and 16,000 jobs into the state's
