A regular meeting of the Anderson County Council was held on June 2, 1992 at 4:30 p.m. in the Old Anderson County Courthouse - Courtroom. Chairman Bob Waldrep presided.

Chairman Waldrep called the meeting to order and Mr. Tom Martin gave the invocation. Everyone stood and pledged allegiance to the flag.

Council presented Mrs. Marney Thomas a plaque for outstanding service to Anderson County as Director of Registrations and Elections. Mrs. Thomas retired May 14.

Council recognized and presented plaques to winners of the Anderson County recycling mascot and slogan contest.

Mr. Doug Cromer requested a short executive session to discuss personnel. Mr. Allgood moved to go into executive session at 4:50 p.m. to discuss personnel and Mr. Banister seconded. Vote was unanimous.

Mr. Banister moved to come out of executive session back into regular session at 5:10 p.m. Mr. Holden seconded and vote was unanimous.

Mr. Tom Martin, County Attorney, stated that Council was briefed on one personnel issue by Mr. Doug Cromer. No action was taken. Council received as information.

Mr. Ed Allgood explained that a prospective buyer for a piece of property at the end of Challedon Subdivision might build sixteen apartment complexes. The only access road for the apartments would run through the subdivision. He said that this should be discussed with the Land Use Commission and this type problem will continue to come up until the County has some type density requirements. Council discussed alternatives to the problem. Mr. Martin explained that this was a type of Land Use control and suggested that the Land Use Commission consider or make a proposal to Council. Council would not be bound by any decision made or recommended by Land Use. Mr. Tony Cirelli said that he would ask the Chairman of the Land Use to call a meeting immediately to discuss this problem.

Mr. Tom Martin explained that County Ordinance #350 and #354 (Anderson County Sewer Use Ordinance and Anderson County Pretreatment Ordinance) has not been approved by the Department of Health and Environmental Control as of this date. He recommended to Council that the public hearings be held because of the cost involved for advertising. Council agreed.

Mr. Martin opened the floor for a public hearing on ordinance #350 which sets sewer rates for Anderson County sewer. Mr. Bill Thompson representing Mr. Gary McAlister explained a problem with the way the County collects delinquent sewer bills. He said his client was stuck with hundreds of dollars of delinquent bills. Mr. McAlister is the owner of Kings Manor Apartments. Mr. Thompson expressed the need for the County to supply an adequate notice to landlords on all delinquent sewer bills. No others wished to speak and the public hearing was declared closed.

Mr. Martin opened the floor for a public hearing on Ordinance #354 which is Anderson County's Pretreatment Ordinance for the Six and Twenty Waste Treatment Plant. Mr. Orien Parrish and Mr. Carl Johnson spoke. The public hearing was declared closed.

Mr. Watson opened a public hearing prior to second reading of Ordinance #356 - fiscal year 1992-1993 budget. The following persons addressed Council on there budget requests:

Mr. Watson presented a request for Mr. Hooper to transfer \$1,000 from #801-155-040 to the "We Care" Program. Mr. Banister asked for approval to appropriate \$500 for the Honea Path Dogwood Club and \$500.00 for the Shamrock Garden Club from District #3 #445 account.

Mr. Holden asked to appropriate \$500 from his #801 account for the "We Care" Program. Mr. Waldrep asked for an appropriation of \$1,500 for the Town of Pelzer to help purchase a backhoe and \$500 for concrete sidewalks on Oak Street in the Town of Williamston. Mr. Allgood moved to approve and Mr. Banister seconded. Vote was unanimous.

Mr. Watson presented the following purchases:

Purchase of one - 1992 John Deere 790D Track Excavator for a total amount of \$131,165.02 from General Tractor Co. Mr. McClure said this will be used for sewer and road maintenance. Mr. Banister moved to approve and Mr. Holden and Mr. Allgood seconded. Vote was unanimous.

Mr. Stephen Crawford presented a bid for construction of a boardwalk at the County Farm Park. The vendor is Michael Alewine for \$7,500.00. Mr. Allgood said that he thought McDuffie High School students could do the project. Council discussed. Council agreed to check with Mr. Gary Kinert with McDuffie High School to see if they would be able to build the boardwalk. Mr. Stephen Crawford will check with him and report back to Council. Mr. Crawford stated for the record, that the County has spent over \$40,000 on a black community club in Pendleton since he has been Recreation Director.

Mr. Rusty Burns explained that the County had been requested to look into doing a Community Development Block Grant program in the areas of housing, sewer and water. He said the area would be in and near the Town of Pelzer. Mr. Burns asked that Council give him permission to explore the options of going for one of the Community Development Block grants for substandard housing. This would be at no expense at this time. Mr. Waldrep expressed his opinion of the project. Council agreed.

Mr. Burn said that they were looking at the possibility of a multi-sports complex on the County Farm Property. This would not require any expenditure of money from the County at this point. He recommended to Council that a committee be formed to look at the options for the use of the County Farm property. Council agreed to discuss during the joint planning meeting scheduled for sometime in June.

Mr. Hooper moved to give the Head Start Program an old secretarial chair. Mr. Allgood seconded and vote was unanimous.

Mr. Carl Johnson spoke under the citizens agenda.

Mr. Watson asked for a short executive session to discuss personnel and a contractual matter.

Mr. Waldrep said that the Management Study was complete and contained a lot of information that Council needed to consider. He asked that Council direct the Administrator to review the study and make his recommendation as to the best way to implement in order to make Anderson County government more effective. Mr. Allgood moved to direct the Administrator to review and make recommendations for implementation based on the COG study. Mr. Hooper seconded. Mr. Holden amended the motion that these recommendations be Mr. Watson's only. Mr. Allgood seconded. Vote on the original motion as amended was unanimous.

Mr. Martin said the purposes of the executive session was to talk about personnel policies, personnel and contractual matters.

Mr. Allgood moved to go into executive session at 7:05 p.m. and Mr. Hooper seconded. Vote was unanimous.

Mr. Hooper moved to come out of executive session back into regular session at 8:00 p.m. Mr. Allgood seconded and vote was unanimous.

A motion was made to approve a personnel proposal suggested by Judge Carl Anderson. The proposal would be that Anderson County's 5-1/4 equivalent magistrates be chopped up into one full time magistrate and 14 parttime magistrates. All of which would fit within the constraints of the number and the dollars that are available. The County Attorney will check into all of the complexities of this to make sure everything is legal. Mr. Hooper seconded. Vote was unanimous.

Mr. Allgood moved to allow Mr. J.R. McClure to conduct a study as discussed in executive session and Mr. Hooper seconded. Vote was unanimous.

Mr. Mike Holden appointed Mr. Robert Foster to the Planning and Development Board.

There being no further business, Council adjourned at 8:15 p.m.
