Jimmy. My comments are in red pen.

For DPS, in decision package #536 (recurring funds request):

o **Unified Access Control Solution**

This initiative will provide an additional layer of protection to the Agency's network by implementing a solution that will control access to the SCDPS network with policies, including pre-admission endpoint security policy checks and post-admission controls over where users and devices can go on a network and what they can do. The cost is \$60,000.

Jimmy, I talked to Barry Langley about this request and it sounds like DPS is comfortable pulling the request. DSIT will be rolling out services that meet many of his requirements next year and these services have already been included in the budget.

From the Law Enforcement Training Council, \$199,800 in one-time funds (#628):

These capital funds would be utilized to replace the current server which due to the utilization of ACADIS is becoming over stressed as well as the current warranty expiring. Usage of the LMS module demands reallocation of memory on a continual basis. Most of the Academy's servers and other IT equipment is outdated and unable to keep up with current demand.

Jimmy, I spoke with Mark Thomas at The Criminal Justice Academy about this request. According to Mark, much of his equipment is approaching end and this budget request addresses that concern.

This money will be used to provide:

New projectors or TV's for 16 classrooms
Cabling and peripherals for classrooms
3 HyperV Servers to replace current end of life hardware
3-4 Terabyte Storage Array
30 Staff PC's

Jimmy,

There are a couple of specific decision packages I wanted to briefly discuss with you when you have a minute. I'm primarily interested in confirming that what the agency is requesting doesn't duplicate something you already expect to pay for centrally.

For DPS, in decision package #536 (recurring funds request):

Also to increase security, DPS need to purchase the following security enhancements to the network:

- o **Unified Access Control Solution**

This initiative will provide an additional layer of protection to the Agency's network by implementing a solution that will control access to the SCDPS network with policies, including pre-admission endpoint security policy checks and post-admission controls over where users and devices can go on a network and what they can do. The cost is \$60,000.

- o **Desktop Data Encryption**

This initiative will further enhance the Agency's data security position.

Given the sensitivity of the data that the Agency handles, encrypting the data on the client computer provides a heightened level of protection from any potential exposure or compromise. The cost to encrypt sensitive data is \$15,000.

Also for DPS, \$84,500 in one-time funds (#1783):

The Department of Public Safety (DPS) is requesting funding to purchase software to secure mobile devices. The agency uses mobile devices extensively and has security risks associated with mobile computing. The software will be used to manage these mobile data devices. The solution will support encryption, remote erase of Agency-managed applications, etc. on the devices. DPS will have the ability to distribute applications to the devices as well as the ability to patch and fix software that resides on personal devices. In addition, this software will provide a method for Android phones to integrate with the Agency e-mail system, i.e. through Exchange Active Sync. The software will provide reports on all devices that are attached to the Agency network.

From the Law Enforcement Training Council, \$199,800 in one-time funds (#628):

Theses capital funds would be utilized to replace the current server which due to the utilization of ACADIS is becoming over stressed as well as the current warranty expiring. Usage of the LMS module demands reallocation of memory on a continual basis. Most of the Academy's servers and other IT equipment is outdated and unable to keep up with current demand.
