Subject: I need Justice from Barred From Applying (Modern Day Slavery)

All:

I was secretly blackball by the state of South Carolina by SCBCB, SCDEW under the authority of Gov Haley. Barred from applying place on my state job applications without notification. SCDEW and SCBCB only admitted to it after verification was exposed to them in written communication. I had done nothing to have such a irreparable marking place on my account that SCDEW and SCBCB both stated in written communication that notification would be sent to all employers but the damage has been done. SCDEW Senior Management made threaten phone call to my home and sent written communications as well stating not to have any contact with them and they have no interest in hiring me. SCDEW went to state in that same letter false accusations of harassment threaten to call local law enforcement and file charges which did not happen at all but a complete distortion.

Gov Haley Office was advise of the problems with SCDEW and SCBCB and attempted to nothing to assist. I offered to come and met with her in Columbia, SC but never receive a response.
