I am writing to you in regards to the hearing that is scheduled to commence on June 21, 2016 at 9:30 a.m. before you.


A hearing was held before Judge Khoury on May 24, 2016 in South Carolina. Prior to the hearing, I requested to appear telephonically as I reside in Lee County, Florida. This matter is an interstate matter wherein enforcement measures are being handled by South Carolina DSS. The matter was established in Florida by the Department of Revenue.

I filed an Agreement to Credit Depository Records and Waive Interest on February 22, 2016 in Lee County, Florida. This agreement was based upon an assumption that the non-custodial parent would make his court ordered monthly payment and continue to make said payment and have a physical relationship with his children which has not occurred as of today's date. I do understand that he has other financial obligations, but taking care of my children are also part of his responsibility. I do understand that the court cannot turn away any payments that he makes, but I would like a reasonable explanation as to why he has failed to make the monthly court ordered amount.
