**DUE TO THE CRISIS IN 'LAME DUCK YEARS' A CITIZEN REQUESTS FOIA AND PRIVACY INFO.**  
Under the South Carolina Freedom of Information Act, §30-4-10 et seq., I am requesting an opportunity to inspect or obtain copies of public records. I am requesting IF ANY constitutional amendment(s) are now being proposed (in your state) which increase Citizens' voting rights ? My copy written proposed Amendment is in first draft form and may need to be amended to better suit the interest of the People. THEREFORE, if your state has other current constitutional amendments dealing specifically with Selections of Justices for the Supreme Court of the UNITED STATES OF AMERICA please provide a copy. Enclosed is a copy my proposed amendment which I believe will expedite and expand Citizens rights, privileges and immunities.

**MULLIGAN'S FIRST DRAFT FOR 28TH AMENDMENT TO THE UNITED STATES CONSTITUTION**

Daniel Mulligan, a Citizen of the United States of America has written the following Amendment to protect the accused and the Citizens from abuses and usurpations. I believe the procedure of "packing the court" that has occurred since John Adams see Marbury v. Madison, 5 U.S. 137 (1803) has benefited lawyers and their political elite but not Citizens:

But as Jefferson Stated in 1776 "Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security...."

**MANKIND'S DUTY TO THROW OFF ABUSES AND USURPATIONS:** The Election of Supreme Court Judges must be held after ratification of this amendment by a national election on first Tuesday after the second Monday in Nov. in odd years. The term of office will be 5 years with 10 year limit and the elections will be staggered. ALL current and or non elected Supreme Court Judge MUST retire within 2 years after the effective date of this amendment After the newly elected court is in place, if a Supreme Court justice dies, retires or is impeached (TWO YEARS or less) before serving the full 5 year term, Congress may appoint a qualified judge for remainder of term .

In Order to prevent conflicts of Interest, and promote of diversity of ideas, the following restrictions and qualifications will apply to all candidates for Supreme Court of the United States of America:

1. Any USA Citizen who is not a convicted felon is eligible provided that USA Citizen has NOT worked in any governmental, Non-profit or educational agency in the past 3 YEARS.
2. The qualified USA Citizen must be over 35 years who has been a Citizen of USA for the past 10 years and can read/write and understand the USA constitution in English.
3. The Supreme Court and judges will be in session 12 month a year with staggered 3 week maximum time of paid vacation . Current 3 month paid Vacations is abolished.
4. To promote fairness and diversity No two judges can be from the same state or have same occupation. Thus only one lawyer, MD, prostitute, etc., can judge simultaneously.
