After my wife divorce me, my daughter was put out into foster care! I couldn't do anything. Because people where all treating me as if I was a bad criminal so I left South Carolina. But Governor Nikki Haley I lie to you not! And I will take a polygraft test! I did not have drugs in my truck. I had

Sage in my truck. And I learn to burn sage, to clear the energy around me, because I have bad headaches and my doctor wanted me to stop taking so much Ibuprofen because its not good for my liver. And I told the officer all I could get out of my mouth and mind! My Words : (Sir you are making a big mistake. Test it!) The officer words: (Shut up! and Man up!) 

SIMPLE POSSESSION OF MARIJUANA

ON THE ABOVE TIME THIS OFFICER RESPONDED TO THE INCIDENT LOCATION IN REFERENCE TO A SUBJECT POSSIBLY SLEEPING AT A RED LIGHT. THE COMPLAINANT(P.GAINES) WAS DRIVING BY THE INCIDENT LOCATION ON HER WAY TO FLORENCE WHEN SHE NOTICED THE SUSPECT(H.BROCK) SLUMPED OVER THE STEERING WHEEL OF HIS TRUCK. THE COMPLAINANT ADVISED SHE WATCHED THE SUSPECT SIT THROUGH SEVERAL CYCLES OF THE REDLIGHT WITH PASSING TRAFFIC BLOWING THEIR HORNS BUT THE SUSPECT NEVER MOVED. THE COMPLAINANT ADVISED SHE FEARED FOR THE SUSPECTS SAFETY SO SHE DIALED 911.

UPON ARRIVAL I SPOKE WITH THE COMPLAINANT AS OFC(CAUTHEN) AND COUNTY OFFICER(L.DAVID) SPOKE WITH THE SUSPECT. AFTER WAKING THE SUSPECT OFFICERS HAD HIM STEP TO THE BACK OF HIS TRUCK ON THE PASSENGERS SIDE FOR SAFETY PURPOSES. THE SUSPECT ADVISED HE HAD BEEN AT HIS DOCTOR IN ROCK HILL AND WAS DRIVING BACK HOME BUT WAS SO TIRED HE FELL ASLEEP AT THE LIGHT. THE SUSPECT ADVISED OFFICERS THAT HE HAD BEEN PULLED OVER IN MCBEE FOR THE SAME THING NOT EVEN AN HOUR BEFORE THIS INCIDENT BUT THOUGHT HE COULD MAKE IT HOME. THE SUSPECT DIDN'T SEEM TO HAVE BEEN DRINKING NOR ON ANY MEDICATION OR OTHER DRUGS. OFC (CAUTHEN) ASKED THE SUSPECT IF THERE WAS ANYTHING ILLEGAL IN IS TRUCK AND DID HE MIND OFFICERS SEARCHING.

THE SLOTS CONTAINED A DRIED GREEN LEAFY SUBSTANCES WHICH IS BELIEVED TO BE MARIJUANA. THE MARIJUANA HAD BEEN IN THE CONSOLE FOR QUITE SOMETIME BECAUSE IT HAD DRIED AND WAS STUCK TO THE CONSOLE WITH THE STICKY FILM THAT FORMS IN CONSOLES AND DRINK HOLDERS. BUT BASED ON MY PRIOR EXPERIENCE THIS OFFICER WAS ABLE TO IDENTIFY THE SUBSTANCE THROUGH SIGHT AND SMELL TO BE MARIJUANA.
