Justice Department Releases Online Naloxone Toolkit

The Department of Justice has prepared an online Naloxone and Law Enforcement toolkit with materials for officer training, policy development, data collection, and education in naloxone use. Naloxone, an opioid antagonist, has been shown to reduce the chance of death when administered to individuals experiencing an opioid overdose. The online naloxone toolkit was developed based on information gathered at a meeting in July with DOJ and OIG enforcement officials, and health and legal experts. The meeting focused on how best to assist law enforcement in establishing a naloxone program.

Drug-Free Communities Grant Recipients Announced

ONDCP has announced \$84 million in Drug-Free Communities (DFC) Support Program grants to fund 197 new grants across the country. In FY 2014, DFC will fund 197 new grants and continue funding 463 grants for current fiscal year cycle. They will also fund 3 new DFC Mentoring grants and continue funding 17 that have already been funded.

Recognizing that local problems need local solutions, DFC-funded coalitions engage multiple sectors to address local drug problems. Since its inception, the DFC Program has funded more than 2,000 coalitions that have been effective in reducing youth substance use.

ONDCP and Federal Partners Form International Demand Reduction Group

In late September, ONDCP convened a roundtable of Federal agency leaders to forge a working group to coordinate Administration efforts to support demand reduction initiatives around the world. ONDCP has noted growing interest from international partners, especially in the Western Hemisphere, in learning about U.S. best practices with respect to interventions and alternatives to incarceration.

The interagency working group on international demand reduction will include representatives from the State and Defense, the Drug Enforcement Administration, the Substance Abuse and Mental Health Services Administration, the National Institute on Drug Abuse, and the United States Agency for International Development.

Recovery Month at the White House: Celebrating 25 Years

On September 17, 2014, ONDCP commemorated the 25th Anniversary of National Alcohol and Drug Abuse Awareness Month with a special event at the White House. The event included more than 175 advocates, recovery coaches, long-term recovery, and others who have been impacted by substance use and its consequences.

The centerpiece of the event was a panel discussion featuring five prominent public figures in long-term recovery from substance use disorders: Cris Carter, a Pro Football Hall of Fame inductee and ESPN Analyst who has been in recovery for 15 years; Ruben Castañeda, a former Washington Post Journalist and author of the book "S Street Rising" who descended into a serious crack addiction; Tim Willson, Mayor of Brooklyn Center, MN, who lost his daughter Christina Huffington, daughter of publisher Arianna Huffington and advocate for her fellow youth in recovery; and former Fox News anchor, who moderated the panel.

The panelists shared their stories and fielded questions submitted by viewers via Twitter. The event was moderated by former U.S. Rep. Patrick Kennedy and Steve Ford, son of former President Gerald Ford and former

Results from the 2013 National Survey on Drug Use and Health

The Substance Abuse and Mental Health Services Administration recently released findings from the Drug Use and Health (NSDUH), the Nation's largest survey of drug use and drug-related attitudes, patterns, and consequences. For the survey, approximately 70,000 Americans aged 12 and older are interviewed.

Here are some key findings from the latest survey:

In 2013, an estimated 24.6 million Americans aged 12 or older were current (past month) illicit drug users, representing 9.2 percent of this population. Current illicit drug use in 2013 was statistically unchanged from 2012 (9.2 percent), following a gradual increase since 2002. Almost 20 million (4 out of 5 current illicit drug users) used marijuana and/or other drugs. Among current marijuana users, 8 million (2 out of 5) were daily or almost daily users, using marijuana on more days in the past month. An estimated 2.8 million persons aged 12 or older used an illicit drug for the first time in the past 12 months – an average of about 7,800 new users per day. Most of these new users (7 out of 10) used marijuana. About 1 in 5 initiated with non-medical use of prescription drugs.
