Mr. Poore called the meeting to order and Councilman Robert L. Wiles gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to approve the minutes of the October 21, 1980 meeting as mailed.

Mr. Newton Rucker approached Council with a request to change the name of Hwy #258 (formerly Rucker Hwy. & Dobbins Bridge Road), which is now known as Marshall Road. He presented a petition with 6 names to the Supervisor requesting that the name be changed back to Rucker Hwy. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to take the present road sign down and advised Mr. Rucker to contact Mr. C.D. Chamblee since this is a state road.

Mr. Jim Workman with the Clarks Hill-Russell Authority and Mr. Scot Ziegler discussed the facts concerning the access areas for Richard B. Russell Lake in Anderson County. On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to direct the Clerk to notify the Council when the Clark Hill-Russell Authority and the Legislative Delegation meets and to have a PRT member present.

Mr. L.H. Senn presented Ordinance #61 - Flood Control for first reading. On the motion of Mr. Gerrard, seconded by Mr. Wright, Council voted unanimously to adopt on first reading.

Mr. Robert L. Wiles stated that Mr. Hurman Barnhill and Mr. Curtis Wilson both members of the Anderson County Recreation Commission had resigned. On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to appoint Mr. Hurbert H. Campbell of Starr and Mr. Joe M. Martin of Iva to the vacancies.

Mr. Trey Senn advised Council of new Subdivision Regulations and the need to adopt them for Anderson County. On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adopt on first reading Ordinance #62 (Subdivision Regulations).

Robert P. Lusk presented Ordinance #60 (Flowers Industries, Inc.) for second reading. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to adopt Ordinance #60 on second reading.

Mr. Dan L. Guffey discussed the need to increase the prices of tax maps and aerial photographs. He presented Council with a price list. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to accept the new fees. Mr. Guffey also gave the Council a brief summary of the office and the progress that it is making.

Mr. Poore suggested Council adopt a Resolution supporting the good work that Mr. Dan Guffey had done for the County. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council adopted Resolution #117 unanimously.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adjourn at 10:05 a.m.
