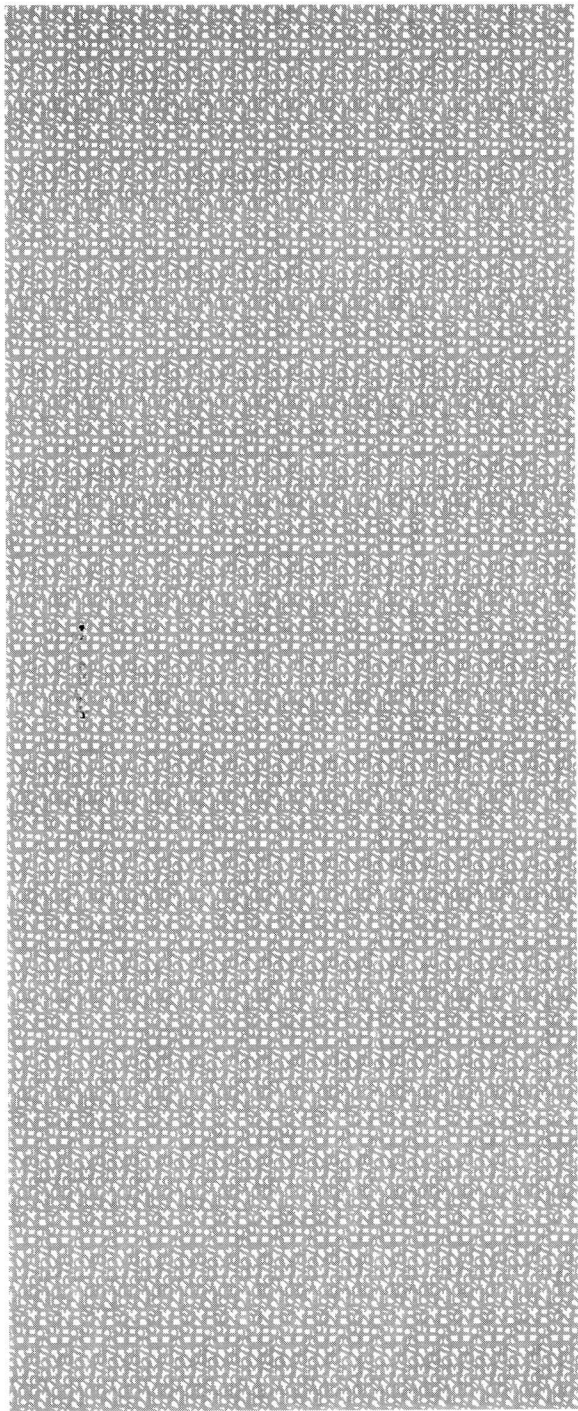



This matter came to be heard before me on **July 23, 2012**. The matter was commenced pursuant to S.C. Code Ann. §57-5-1495 (1976) for a money judgment for unpaid tolls, administrative fees, court costs, and civil penalties. Present in Court for the Plaintiff was, the Defendant, **Emily Cherry Mactavish**, ☐ did appear ☒ did not appear. After considering the pleadings and the evidence presented in this matter, I make the following findings of fact:

1. The Plaintiff properly served the Defendant with a "Citation for Failure to Pay Toll" on or about **6/21/2012**, pursuant to S.C. Code Ann. § 57-5-1495 (G) (3) (1976).
2. The Defendant, Emily Cherry Mactavish, was the registered owner of the following vehicles between the relevant dates of the violations alleged in the pleadings.

3. The Plaintiff presented a prima facie case for **139** toll violations, between the dates **12/18/2010 - 6/24/2011** as alleged in the pleadings.
