I was in my first week before I was arrested. My goal was to support my daughter she's 3 years old and myself. I went to York Technical College for a year but I dropped out so I could get a job. My plan was to go back until I made plans to join the National Guard to get my CDL license. My dream is as was to make enough money

to have my businesses. I have my family and friends supporting me. I also played football all the way to the 10th grade but decided school was more important because I knew graduating would make my family proud of me. I am asking you for a pardon because I believe some people deserve a second chance and I won't mess up again. If I come to jail again I am willing to do the whole 20 years or added time to my next sentencing. A lot with my charge Sexual Criminal Conduct (SCC) have gotten no more than 10 years. Some have gotten time - serve plea guilty to assault & battery or dismiss because of mistrial. Some have gotten 3-5 years and are repeat offenders. I have done

my research and if its your second or third time the judge or jury suppose to give you life imprisonment or the death penalty. In my 26 years I have never been in trouble except tickets or citations. I hang around positive people and I try to keep my peers at a positive level. All of my young, siblings and cousins look up to me as a role model. My plan are to get myself in the law library and stay positive and stay focus. I believe bad things happen to good and bad people for a reason. The victim and her family are regretting what they did to me. They was crying when the judge gave me 20 years and they plan to come see me while I am in prison. During my time in jail I have spoken close to God he is trying to show me the way. I help my mother and my wife raise their kids which

is my little sister Andrick (12) and my
cousin/nephew/brother Jalen (13).
When my daughter was born I lost
my job so I became a stay home dad.
My daughter and I have to bond
but I'm scared my bond may get broken
if I'm not in her life. She is also named
after me Syleah Jerree Brooks and
she is my twin. Only thing I regret
is staying in football because I know I
would have made it to the NFL. I
am glad you won the election I believe
in you. I don't vote but I would have
voted for you if I was out. Team
Obama / Team Haley!!! If you get the
time to read this and go over my
background I hope you can give me
a pardon and I will make a promise to
you sign a contract if I mess up again
I will spend the rest of my life in
jail. I plan to get a Motion of Appeal
to BCR grievance my case. Thank
