Greenville County businessman Johnny Edwards says he's hoping to become chief executive for the state highway department in part because "the Upstate is due for some influence in Columbia."

**Note:** Haley spokesman Doug Mayer declined to say who else has applied for the job, citing a longstanding policy of the Governor's Office not to comment on nominations until they are complete.

A federal ban on Internet gambling would be restored under legislation introduced Wednesday by Sen. Lindsey Graham and others who say the Justice Department mistakenly allowed such gaming in a 2011 opinion. Graham, R-Seneca, said Congress, not the Justice Department, should have the final say on whether betting online is legal.

**Note:** "Allowing Internet gaming to invade the homes of every American family and to be piped into our dens, living rooms, workplaces, and even our kids' bedrooms and dorm rooms is a major decision," Haley wrote in a Monday letter to congressional leaders. "We must carefully examine the short- and long-term social and economic consequences before Internet gambling spreads."

The House has approved a bill clarifying that the State Election Commission is responsible for South Carolina's future presidential primaries. The measure approved Wednesday would delete from state law a reference to the 2008 election cycle. Future presidential primaries will be funded through the budget like any other election, offset by filing fees paid by candidates.
