America's *biggest criminal problem*

Is every government Official in America (City, County, Federal, & State), that, either knowingly or unknowingly, chooses to freely **break the Law**, by violating the **good behavior provision** in **America's Constitution, Article III, Section 1.**, which is the **Law** that **Legally Rules America**.

Explanation Time:

ARTICLE I
