## Centers for Medicare and Medicaid Services

### Participants Selected for CMS' Accountable Health Communities Model

CMS will implement and test, over five years, the three-track Accountable Health Communities (AHC) model to support local communities in addressing the health-related social needs of Medicare and Medicaid beneficiaries by bridging the gap between clinical and community service providers. Social needs include things such as housing instability, food insecurity, utility needs, interpersonal violence and transportation.

CMS has recently announced the participants for the Assistance and Alignment Tracks, two of the three tracks of the AHC model. The AHC Assistance Track organizations will provide person-centered community service navigation services to assist high-risk beneficiaries with accessing needed services. The AHC Alignment Track organizations will also provide community service navigation services, as well as encourage community-level partner alignment to ensure that needed services and supports are available and responsive to beneficiaries' needs.

Overall, 12 Assistance Track and 20 Alignment Track bridge organizations representing rural and urban communities across 193 counties in 23 states were chosen to participate in the model. The Assistance and Alignment Tracks of the AHC model will begin on **May 1, 2017**.

## Medicaid and CHIP Payment and Access Commission

### Medicaid Hospital Payments

The Medicaid and CHIP Payment and Access Commission (MACPAC) released a new issue brief on Medicaid hospital payments. The brief finds that, overall, Medicaid hospital payments are equal to or even higher than Medicare payments. This is a surprising finding as Medicaid physician payment rates, when compared to Medicare, are generally lower.

MACPAC's analysis did include supplemental payments to hospitals, which account for 49 percent of fee-for-service payments to inpatient hospitals.

## From Congress

### House of Representatives

#### Amendment to Create a Federal Risk-Sharing Program

On **April 6, 2017**, the U.S. House of Representatives Rules Committee passed an amendment to **H.R. 1628, the American Health Care Act (AHCA)**, that would create a federal risk-sharing program in order to help compensate individual market insurers for high-cost enrollees. If the AHCA were to pass and become law, the amendment would appropriate a sum of \$15 billion from **January 2018 through December 2026**. The program is largely modeled after a high-risk pool arrangement implemented in Maine.

### Senate

#### Senate Votes to Eliminate Option to Filibuster Presidential Nominees to Supreme Court

On **April 6, 2017**, the U.S. Senate in a historic move voted 52-48 to alter Senate rules and eliminate the option for the minority party to filibuster presidential nominees to the U.S. Supreme Court. In common discourse, this has been referred to as invoking the "nuclear option" in the Senate. Supreme Court nominees can now be approved by a majority, or 51, votes. The ability for Senators to filibuster legislation, however, remains,

and still requires 60 votes to attain passage. According to Politico, President Trump's Supreme Court nominee, Neil Gorsuch from Colorado, is expected to be confirmed by **Friday April 7, 2017**.

To realize their goal of achieving statewide multi-payer care delivery and payment reforms for roughly 80 percent of the population within participating states, SIM states and territories are helping health care providers transform their practices to be more patient-centered, while improving patient outcomes and reducing health care spending.

This brief from CHCS discusses the practice transformation assistance activities and related efforts that four SIM states, Colorado, Idaho, Oregon, and Vermont, are offering to their provider communities. ## **The Impact of ACA Medicaid Expansions on Applications to Federal Disability Programs**

Mathematica has a publication available that estimates the impact of Medicaid expansions via the Patient Protection and Affordable Care Act (ACA) on applications to federal disability programs in 15 states that expanded Medicaid in 2014. The study found that 6 states experienced a statistically significant impact on SSI application rates and 6 experienced a statistically significant impact on SSDI-only application rates.

### **Decision-Making Ability and Risk of Elder Mistreatment**

NCEA has released a new research to practice publication: "Decision-Making Ability and Risk of Elder Mistreatment." This publication discusses factors pertinent to the decision-making ability of older people including: changes in the brain, cognition, social functioning, and how impaired decision-making ability can lead to an increased risk of elder mistreatment. The brief also describes what to do if you notice changes in an older person's decision-making ability and includes tools to reduce the risk of abuse and exploitation while maintaining and promoting autonomy.

## AARP: BankSafe Grants: Preventing Exploitation Through Bank Staff Training

The Request for Proposals (RFP) from AARP seeks to identify multi-disciplinary coalitions positioned to assist AARP with its BankSafe initiative. BankSafe aims to protect consumers from financial exploitation and keep retirement savings safe. AARP is seeking to partner with the financial industry to create a free online training program that will help employees in local financial institutions to detect and prevent exploitation. The purpose of this grant is to fund multi-disciplinary, multi-stakeholder collaborative groups (composed of aging advocates that are working in conjunction with financial institutions) to help develop the content of the training, which should include state-specific content.

Selected coalitions will receive a grant of \$10,000 to help develop and disseminate training to banks and credit unions.
