FYI - State Treasurer's Office has advised that they have arranged to release direct deposit information in time for them to transfer the information to individual banks for a January 1, 2016 posting; however, **there is no guarantee that all banks will post on that date.** It depends on your individual banking institution, as to when the direct deposit will post.

Also, for employees that receive a "live" (paper) check, please be advised that you can pick up your check on Friday, January 1<sup>st</sup> **between 10:00 am – 11:00 am only**, from the 1<sup>st</sup> floor of the Wade Hampton Building, from the general receptionist/security desk area. An HR Representative will be there to distribute checks during this **one hour timeframe only**. Checks can only be picked up by the employee. Please be prepared to show identification and sign for your check. If proper identification is not presented, the check will not be released.
