Nikki R. Haley
Governor of South Carolina

Nikki R. Haley was elected the 116th governor of the State of South Carolina in 2010. She is the first female governor in South Carolina history.



From the start of her administration, Governor Haley has been proud to announce 39,000 new jobs created and over \$9.4 billion invested in South Carolina.

Haley began her career in public service when she was first elected to represent the 87th District in Lexington County in 2004. In 2008 she was re-elected to a second term with 83 percent of the vote.

Governor Haley played a pivotal role in securing the Royal Bank of Canada as the sponsor for the RBC Heritage presented by Boeing, helping to secure the tournament's sponsorship for its five-year run.

Haley is a South Carolina native and graduate of Clemson University with a B.S in accounting. Her first job was bookkeeping for her family's clothing store at the age of 13. Following college, Governor Haley worked in accounting management for FCR, Inc. and its five subsidiaries based in Charlotte, NC, before returning to her family business where she helped oversee its growth into a multi-million dollar operation.

Governor Haley's husband Michael is a full-time federal technician with the SC National Guard and an officer in the Army National Guard. They have two children, Rena, 15 and Nalin, 12.
