The Governor's position on this has been practice has consistent, twice proposing in Executive Budgets that this proviso be eliminated. While the Governor feels that a fee-for-service arrangement between Universities and the Department of Public Safety is a model preferable to the current one, either way a state agency would bear the cost of this public safety service. A veto would not have changed the cost of the traffic control, nor would it have stopped the traffic control from occurring. Accordingly, we have chosen to maintain a constructive approach to improving more technical aspects of state fiscal practices such as this one, instead of using the blunt veto pen this year.

My weekender is on a proposed budget proviso that was pulled without discussion, but made me curious....

It would have eliminated the proviso barring DPS from charging for traffic control, thereby allowing the agency to charge USC and Clemson, for example, for traffic control during home football games. According to the numbers I have from DPS, the agency spends more than \$400,000 on traffic control at Clemson and Carolina football games, plus about \$11,000 for SC State football games. Adding in traffic control at other sporting events (Darlington races, horse races and the Heritage) brings the total to about \$520,000.

SO, my question for the governor is whether she thinks DPS should be able to recoup the money from colleges or whether this is a service the agency needs to provide for the public's safety. And please expand on the answer. Clemson, USC and SC State are the only school in the state DPS provides traffic control for, and only for football games. While Haley's never vetoed the proviso, which has been around since at least 1996-97, she did twice vote to uphold Sanford's veto of the proviso. (It was veto 16 on the 2009-10 budget)
