Here is what you can say –

Our legal counsel, Richele Taylor, has put a hold on board appointments where one candidate is submitted instead of the “list” as required by statute. The recent FTC v. Dental case held that decision makers on a state licensing board must be subject to active supervision by the state, and one of these factors is how they are appointed. By providing “one” person instead of a list, this could be construed as a lack of supervision by the state. Also, past case law indicates that a board must submit a list. We have asked multiple boards who provided one member to submit a list to allow the Governor to exercise her authority. For those who have not done so, we have put on hold their appointments while we determine how best to work through this issue. We should resolve this before session, however we are being careful to ensure we maintain the requisite supervision.
