## Report Fraud and Abuse



## Medicaid Renewal

Each year you must renew your Medicaid. When it is time to renew we will send you a form, called the Medicaid Renewal Form. The form will tell you what information you must return to us. We may need to know how much money you earn, what property you own, or if you have childcare expenses. You must answer all the questions on the form and sign it. It is important that you mail this back to the address listed on the form and mail it back by the due date. **If you fail to turn in your Medicaid Renewal Form on time, your Medicaid may end.** If you have questions about this process, call us at **1-888-549-0820**.

Thank you for your letter of March 12, 2008. We will begin sending the new Healthy Connections cards on March 26, 2008 and we believe it will take three weeks to send all the cards out. If you have not received your card by April 15, 2008, please contact our Resource Center at 1-888-549-0820 and the staff will assist you in getting a replacement card.

Currently, First Choice by Select Health of South Carolina and South Carolina Solutions are the health plans serving Charleston County. Carolina Crescent Health Plan will begin serving Charleston County on April 1, 2008. We do expect more plans to begin serving your county in the next few months, so you might want to wait until May to explore your options.
