### Governor Nikki Haley News:

**McClatchy DC:** Haley 'giddy' about a GOP-dominated Washington

Gov. Nikki Haley of South Carolina is giddy over the prospect of having Republicans controlling Congress and the White House. And Donald Trump, who she tangled with earlier this year before saying this spring she'd back the nominee and then voting for him last week? She's hopeful. "I'm just giddy, and if you talk to any of the governors here, we are so excited at the possibility and the opportunities that are going to be here," Haley said during a meeting of the Republican Governors Association. The governors are meeting this week at the posh Waldorf Astoria Resort, in the shadow of Disney World. Haley appeared on a panel called "Leading the Charge" with three other governors, then participated in a news conference. In January, Haley gave the GOP response to President Barack Obama's State of the Union address. She criticized those in her party, urging people to resist "the siren call of the angriest voices." Trump fired back.

The nation's Republican governors could be Donald Trump's biggest headache. Politically, they are so much that Trump is not. They represent broad, diverse constituencies that demand results they can see in their daily lives. They have usually worked their way up, starting with local offices or running small local businesses. So as the GOP governors meet this week with each other, donors and corporate officials at the lush Waldorf Astoria resort in the shadow of Disney World, many are very careful when discussing the president-elect. They're keeping enough distance so that if he proves to be a political liability, they'll be fine. "Governors need the White House, but they're pragmatic," said Henry Barbour, Republican Party committeeman from Mississippi. Trump needs the governors. Republicans will occupy at least 33 state houses next year, their best showing since 1922, and they have vast political networks in their states.

**NOTE:** Gov. Nikki Haley of South Carolina tangled with Trump earlier this year. When she gave the GOP response to the State of the Union address in January, she criticized those in her party, urging people to resist "the siren call of the angriest voices."

**NOTE:** Haley endorsed Sen. Marco Rubio, R-Fla., for president, and after it became apparent Trump was the nominee, she said she would back him.

**NOTE:** Haley voted for Trump, but said last month, "The election has turned my stomach upside down." Tuesday, Haley said, Trump is "talking about inclusion... so far he's done well." Haley hoped "he continues to be disciplined in his comments."

**NOTE:** The governors were more circumspect when asked about Trump chief strategist Steve Bannon, who many civil rights groups are protesting because of his ties to white supremacists. Haley said she didn't know Bannon. Burgum said, "I'm not close enough. I'm not a political insider."

**NOTE:** Gov. Sam Brownback of Kansas found Pence's remarks "exciting." Brownback particularly appreciated how "he showed us how we could do some things in the short term." Haley raved: "He stands by his word. He's going to give good advice when needed."

Republicans are still celebrating their election victories, but the country's GOP governors warned this week that they need to move fast on many of the changes that have been promised to voters. The Republican Governors Association held its annual conference at a resort near Disney World this week where several governors talked eagerly about how the election of Donald Trump could herald sweeping changes on everything from health care to education. But many of them said those changes need to come soon before the nation and Republican leaders get caught up in the 2018 election cycle. "We cannot squander this opportunity," said Arizona Gov. Doug Ducey. Republicans now control the White House and Congress. And Wisconsin Gov. Scott Walker pointed that this was the first time there has been this many GOP governors across the country since the 1920s.

**NOTE:** South Carolina Gov. Nikki Haley called it a "new day" for statehouses across the country, but she added her own admonition. "We can't celebrate too long, we've got to get to work," Haley said. "And that means 30 days, 60 days, 90 days, 120 days, all of us have to get to work."

There aren't many elected Republicans in America happier about Donald Trump's election than Florida Gov. Rick Scott, an early Trump supporter in a battleground state dominated by Jeb Bush and Marco Rubio loyalists. Not only is Scott a fellow super-rich businessman and political outsider who ran against the GOP establishment, he also ran a health care company, Columbia/HCA, that was targeted by the Clinton administration in the 1990s for Medicare fraud. So you can understand why Scott — a likely candidate for U.S. Senate in 2018 — is smiling big this week. "I now have a president I can talk to. I talk to Trump a lot. I have both a president and a vice president who are friends of mine," Scott, 63, said Tuesday in Orlando, where he is attending the annual conference of the Republican Governors Association.

**NOTE:** South Carolina Gov. Nikki Haley nine months ago saw Trump as "everything a governor doesn't want in a president." Tuesday, one week after his election, she described herself as "giddy" and saw nothing but opportunity.

**NOTE:** Haley said it's inevitable governors will have disagreements here and there with Trump but, "We are in a far better situation than we were a month, two months, two years ago. The idea that Republican governors can now have a seat at the table and actually get some things done . . . is what we care about."

Republican governors meeting for the first time since Donald Trump won the White House are gearing up for Washington to begin passing a broad-ranging conservative agenda after years of gridlock, bolstered by their party's wide electoral success. South Carolina Governor Nikki Haley, who once quipped that Trump represented "everything a governor doesn't want in a president," said during a panel discussion at an annual meeting of the Republican Governors Association in Florida that she was "just giddy" about the possibilities that lay ahead for Republicans, who now control the majority of states and the nation's capital. "We can now start to really govern," she told reporters. "I've never known what it's like to have a Republican president. I can tell you, the last six years, Washington was the hardest part of my job." Republicans now hold 33 governorships, the highest for the party since 1922. They also have majorities in roughly two-thirds of state House and Senate chambers. Still, observers say that ultimately the governors could find it difficult to see eye-to-eye with Trump when it comes to governing and policy matters that could dramatically affect their state

budgets, access to federal funding and job growth.

**NOTE:** Haley and other chief executives repeatedly brought up Mike Pence, the vice president-elect and a fellow governor from Indiana, as they reassured themselves that they'll have a good relationship with Trump's White House.

**NOTE:** "I don't know Bannon, so I don't have much to say about that," Haley told reporters.

**NOTE:** Just nine months earlier, Haley had been much less accepting about a potential Trump presidency. Asked about her changed tune, Haley said her previous remark was something said during a primary campaign, she's always believed in supporting the eventual nominee and Trump has shown greater self-control since his victory.

South Carolina Gov. Nikki Haley said Tuesday the fact that Republicans now control the White House, Congress and so many governors' mansions has left her "giddy." Haley and the rest of the Republican Governors Association are meeting this week in Orlando, Fla., to discuss their party's victories last week and how they hope to work with President-elect Donald Trump. On election night, Republicans picked up three states now governed by Democrats: Missouri, New Hampshire and Vermont. North Carolina's governor's race is still being contested. But even if Democrat Roy Cooper's lead holds and he defeats incumbent Pat McCrory, the GOP will hold governorships in 33 states, the most in nearly a century. That's lent almost a party atmosphere to the conference proceedings, even for governors who had expressed reservations about Trump, like Haley and New Mexico's Susannah Martinez. During the campaign, Martinez said Trump's "offensive rhetoric" raised questions about his fitness to be president. Now she says she's confident Trump will deliver on campaign promises and "his commitment to make sure that America is great again."

**NOTE:** Haley said she always supported him, despite concerns about his rhetoric. In Orlando, she said "words matter" and she was still watching Trump's statements. "President-elect Trump has done well," Haley said. "I hope he continues to do that. I hope he continues to be disciplined in his comments."

Gov. Rick Scott called for "disruptive change" in a Donald Trump administration - while admitting that on many issues, he doesn't know what Trump will do. He also appeared to open the door to a potential U.S. Senate run in 2018 for incumbent Bill Nelson's seat - but he punted when directly asked about Trump's widely condemned appointment of Breitbart editor Steve Bannon as chief adviser. Scott was speaking to reporters at the Waldorf Astoria Orlando Tuesday on the first full day of Republican Governors Association conference, which brought together governors from across the country just a few weeks after they won control of what will be 34 governorships across the nation. Scott repeatedly compared Trump's rise as an "outsider" businessman to his own election as governor in 2010.

**NOTE:** At a joint press conference later in the day, Scott, New Mexico Gov. Susana Martinez, Wisconsin Gov. Scott Walker, South Carolina Gov. Nikki Haley all avoided comment on Bannon, with Haley also saying she did not know him.

**NOTE:** But Haley, who opposed Trump earlier this year, advised the president-elect that "communication and tone matter. The power of words matter. ... What you never want to see is any divisiveness in a state or the country."

S.C. Gov. Nikki Haley could be about to take another step into the national spotlight. This week, Haley could be elected vice chair of the Republican Governors Association. Haley is on the RGA's executive committee and is a contender for its vice chairmanship. Typically, vice chairs rise to become chair of the association the following year. For Haley, that means if she is elected vice chair, she would chair the GOP governors group in 2018, her final year as S.C. governor. The Republican governors are meeting this week in Orlando. **The State:** Rec Commission board member resigns

One of the seven Richland County Recreation Commission board members that Gov. Nikki Haley intends to fire has walked away on his own. Wilbert Lewis resigned Tuesday, becoming the only board member to step down after turmoil at the troubled commission. Lewis was not one of the five board members that a group of Richland County legislators had accused of allowing unwarranted pay raises and widespread nepotism at the commission. After those lawmakers requested Haley remove the five board members, the Republican governor moved to fire all seven. "Although I believe he is one of the few on this board who have acted in the best interest of the agency and the employees, I respect his decision to allow the commission to move forward with a new board in a new direction," said state Sen. Joel Lourie, D-Richland. "His departure should be viewed as a sacrifice by a respected public servant who is putting the greater good ahead of his personal ambition."

A South Carolina agency is holding off on recommending any changes to abortion clinic regulations after being inundated with responses to its drafted proposal. The state Department of Health and Environmental Control confirmed Tuesday the process is delayed indefinitely. Spokeswoman Cassandra Harris says the agency received nearly 460 comments on proposed changes put out in September for public review. The agency had expected to hold a hearing in December, then send recommendations to legislators. Abortion rights advocates praised the department's move. Suggestions they opposed included requiring physicians who perform abortions to be board-certified in obstetrics and gynecology and requiring clinics to meet higher surgical standards. Planned Parenthood regional spokeswoman Vicki Ringer says the decision shows South Carolinians "spoke out loudly and in huge numbers" to oppose medically unnecessary restrictions.

Olin Booker was out of a job, out of money and out of time. In January 2016, he was packing to move back to Georgia when he was advised by his VA administrator to visit the Greenville SC Works Center and talk with them about finding a job. He decided to give it a try, and there he met Frank Mattox, an SC Works veteran's representative, who within hours had lined up an interview with Michelin Prime. Two days later Booker had an interview with the company and was hired on the spot. Booker, who served eight years in the U.S. Army Reserves, is one of the 8,000 veterans who were placed in jobs by the S.C. Department of Employment and Workforce (DEW) last year. South Carolina also has one of the lowest veterans' unemployment rates in the country at 4.4 percent. "(SC Works) turned my life around. I was in the process of packing, getting ready to move," he said. "I hadn't worked since 2012. My savings were depleted; I had just enough money to pay my rent. I was two weeks from being homeless."

He said he was gratified by Trump's stated commitment to boosting defense spending, recalling that his own short-lived bid for president was centered on strengthening the military.

President-elect Donald Trump hadn't been seen in public for days when he walked into New York's 21 Club to applause from fellow diners. The unannounced evening out with family was a contrast to the behind-the-scenes machinations that suggested a struggling transition as names surfaced and sank for top administration positions. Not to worry, Trump suggested in a Tuesday night tweet: "Very organized process taking place as I decide on Cabinet and many other positions. I am the only one who knows who the finalists are!" Before dinner at the midtown Manhattan restaurant — he broke with protocol and left his press contingent behind — Trump met with the head of his transition team, Vice President-elect Mike Pence, but another day passed without a Cabinet announcement. Strains were showing within the process. Trump's allies engaged in an unusual round of public speculation about his potential appointments. Former Rep. Mike Rogers, a respected Republican voice on national security issues, quit the transition effort. And an apparent clerical oversight temporarily halted the Trump team's ability to coordinate with President Barack Obama's White House.

**Associated Press:** Government forces pound Aleppo for 2nd day

Pro-government forces pushed on with their bombardment of the Syrian city of Aleppo Wednesday on the second day of a massive offensive against the city's rebel-held eastern quarters. The Britain-based Syrian Observatory for Human Rights monitoring group says 20 civilians have been killed by the fierce bombardment that resumed Tuesday after a three-week respite. Local activists counted at least 50 artillery and air strikes since the morning. The U.N. estimates that pro-government forces have trapped some 275,000 people in Aleppo's eastern quarters in a strict blockade enforced since August, as ground and air forces meanwhile pound the area's hospitals. The U.N. warned last week that food rations inside Aleppo's rebel-held districts could be depleted this week. Syrian President Bashar Assad said in an interview published Tuesday with Portugal's state-run RTP television channel that his forces were fighting to liberate civilians from "terrorists," while most of the rebels in Aleppo, numbering around 8,000 according to the U.N., are Syrians who have been fighting to overthrow Assad.

**Associated Press:** The 'Trump effect' weighs on France's presidential election

Donald Trump's election in the U.S. has given a new boost to conservative leaders in what may be the next major populist battleground, France, where far-right leader Marine Le Pen is convinced that her anti-immigration, anti-Islam views can lead her to the presidency in five months. Former President Nicolas Sarkozy, running to get his job back, says that Trump's election shows that politicians must listen to "the wrath of the people." "Mr. Trump wants to defend American interests? Fine, I want to defend French interests and those of Europe. What Americans allow themselves, why should we

refuse that for France?" Sarkozy said in a rally in the southern city of Nice on Tuesday night. Sarkozy is facing tough competition in his party's two-round primary that starts Sunday. Polls have repeatedly placed him behind ex-Prime Minister Alain Juppe. Another major contender, former Prime Minister Francois Fillon, is gaining popularity as he also presents himself as an alternative to Sarkozy.

Iran's two top leaders — its president and the country's supreme leader — both sought Wednesday to calm concerns in Iran over the future of Tehran's nuclear deal with world powers in the wake of Donald Trump's election for U.S. president. President Hassan Rouhani said the country will remain committed and loyal to the deal, regardless of the outcome of the U.S. election. Supreme Leader Ayatollah Ali Khamenei said Iran was indifferent to the result of the U.S. vote, insisting the Iranian nation was "not worried" about the future and was ready for any fallout from the U.S. election. Trump's much publicized criticism of the nuclear deal and his campaign vows to renegotiate the terms and increase enforcement of the deal that put off the threat of Tehran developing atomic weapons has sent jitters across Iran. "If a president is changed here and there, it has no impact on the will of Iran," Rouhani said in a speech broadcast live on state TV from the city of Karaj, where he was visiting. "Based on the deal, we implement our commitment."

Greenville Water officials are monitoring their water to make sure the Pinnacle Mountain Fire doesn't force them to change their supply. The fire is being directed toward the Table Rock Reservoir, one of three sources for the water company. One of the risks is that an exceptionally heavy rain could send piles of soot into the water, which would require either extra treatment methods or a switch to lean even more on the other two sources, the North Saluda Reservoir and Lake Keowee, said Olivia Vassey, communications manager for the water company. The soot risk will diminish over time and smaller amounts of rain would not pose as much of a risk to the water supply, she said. As smaller rains fall and leaves start to layer over the fire debris and nature takes over, any risk of soot in the water system will likely go away, Vassey said.

Smoke from the biggest wildfire in the South Carolina mountains since 1978 is likely to continue blanketing the Upstate for the rest of the week as firefighters continue to battle the blaze and the weather offers little hope for relief, officials said. Children with asthma and other respiratory illnesses are particularly hard hit by the clouds of smoke from area wildfires hovering over the Upstate, a local pediatrician says. So special precautions should be taken at home, in schools and in the community to protect them, said Dr. Steven Snodgrass, medical director of pediatric pulmonology for Greenville Health System Children's Hospital. Outdoor exposure should be limited in these vulnerable children, especially if they are already battling colds and respiratory illnesses at this time of year, he said. And windows should be closed to limit exposure. Requests from parents and caregivers to skip recess and other outdoor activities should be honored, he said, along with athletes participating in outdoor sports who are susceptible.

"Smoke from these fires can irritate the eyes and respiratory system, as well as aggravate or exacerbate chronic heart and lung diseases," said Rhonda Thompson, chief of DHEC's Bureau of Air Quality. People with respiratory health issues are advised to limit their time outdoors to avoid the smoke and to take measures to prevent outdoor smoke from getting inside, according to DHEC. Keep windows and doors closed and keep fresh-air intakes closed and filters clean in air conditioning and central heating units to prevent smoke from getting inside, officials said.

Smoke coming from wildfires in the mountains of South Carolina, North Carolina, Tennessee and Georgia could affect breathing and visibility in the Midlands, according to officials. The National Weather Service issued a code orange air quality alert Tuesday morning, warning smoke from the wildfires could affect several areas of the Midlands – including Richland, Lexington, Kershaw, Newberry, Fairfield, Sumter and Lee counties. Code orange means children and adults, including those with respiratory diseases such as asthma, should limit prolonged outdoor exposure. Assistant state epidemiologist Dr. Melissa Overman said the particulates in the smoke will aggravate most lung conditions, chronic respiratory conditions and some heart conditions.

A code orange air quality alert was issued for the Lowcountry until midnight Wednesday as smoke from wildfires in the mountains again fumes the region. Lowcountry residents are waking up to a blanket of dense fog and smoke from wildfires in the mountains. Visibility will be reduced to a quarter mile or less at times, according to a National Weather Service fog advisory in effect through 10 a.m. Meteorologists say drivers should use low-beam headlights when needed, prepare for a longer commute and leave plenty of distance between cars. An air quality alert was issued for the Lowcountry through midnight Wednesday as dozens of blazes continue to spread in the southern Appalachian region. The code orange alert means fine particles from smoke could approach dangerous levels for sensitive adults, according to the weather service. Forecasters expect the smoke to stick around overnight and through Thursday. A coastal flood advisory is also in effect until 11 a.m. for downtown Charleston and surrounding low-lying areas. High tide is expected to occur at 9 a.m. and peak between 7.6 and 7.9 feet. Moderate saltwater flooding is possible one to two hours before and after high tide.

The National Weather Service has issued a special announcement of smoke impacting areas of Beaufort and Jasper counties as wildfires spread across the southern Appalachians. The smoke impacted Beaufort County on Friday, according to Daufuskie Island Fire Department Chief Edward Boys. Boys said a statement made by Hilton Head Island Fire & Rescue that the smoke came from open burning on Daufuskie was incorrect. Areas of Daufuskie are beginning to experience smoke again on Tuesday as it is carried to the area by south and southeastern winds, Boys said. In addition to Beaufort and Jasper counties, areas of Allendale, Hampton, Colleton, Dorchester and Berkeley counties may also experience smoke, according to a National Weather Service release. Visibility may be as limited as one to three miles at times, the release said. Active children and adults as well as those with respiratory ailments that can be triggered by smoke should limit outdoor activity and prolonged outdoor activities should be limited for everyone, the release said. Motorists should also be alert for sudden changes in visibility.

What Hurricane Matthew ripped out, Harbour Town is hastening to put back in. A small fraction of it, anyway. Though it would be near impossible to replace all the trees downed on the home of the RBC Heritage Presented by Boeing, crews already are on site this week to plant more than a dozen large oaks and palms in key areas of the course, which reopened for play just last week. The oak trees are all at least 55 feet tall, with trunks some 18 inches in diameter. Sabal palms are in the 30-foot range. One magnolia tree will be put back at Harbour Town's third hole. And next month, seven tall pines arrive. "Replacement trees of significance," said Cary Corbitt, vice president of sports and operations at Sea Pines Resort. Though it represents maybe a little more than 5 percent of the 400 or so Harbour Town trees knocked down by Hurricane Matthew, those spots were deemed critical either to maintain shot strategy or to fill in areas where too much tree canopy had been lost.

The families of some of the four people killed at Superbike Motorsports in Chesnee 13 years ago are filing a lawsuit against accused killer Todd Kohlhepp. Melissa Brackman — the widow of Scott Ponder, one of the Superbike victims — confirmed to the Herald-Journal Tuesday afternoon that she is among the family members planning to file a wrongful death suit against the Moore real estate agent who investigators say confessed to the quadruple homicide. When someone dies due to the fault of another person or entity, the survivors may be able to bring a wrongful death suit. This kind of lawsuit seeks compensation for the survivors' loss, including lost companionship, funeral expenses and lost wages from the deceased. Scott Ponder, 30, built Superbike Motorsports from the ground up. He, along with his 52-year-old mother and part-time employee Beverly Guy, and employees Brian Lucas, 29, and Chris Sherbert, 26, were killed at the store Nov. 6, 2003. "I'm not too sure of any details at this point," Brackman said of the lawsuit.

Jurors in the murder trial of a white former South Carolina patrolman who shot an unarmed black motorist will see an animation of the shooting before the prosecution rests its case. Michael Slager is charged with murder in the April 2015 death of Walter Scott as the motorist fled a traffic stop. The shooting was captured on cellphone video. The prosecution was expected to rest Tuesday, but lawyers spent much of the day arguing over the state's final witness. The witness, Bill Williams, compiled the animation from cellphone and dashcam video, drone footage of the crime scene and police call audio. The defense argued that Williams, who's largely self-taught, didn't qualify as an expert. Judge Clinton Newman ruled he could testify and jurors will see the animation Wednesday.

After a legal challenge sidetracked a plan to rest their case against former officer Michael Slager, prosecutors on Wednesday morning are expected to call their last witness in hopes of leaving jurors with another look at Walter Scott's shooting death. Bill Williams, hired by the prosecution for his expertise in virtual crime-scene re-creation, will show the jury a simulation of the foot chase that led to a confrontation between Slager and Scott. But missing will be any portrayal of the struggle that Slager said ended with Scott getting control of his Taser, which drew the officer's gunfire. With contentious cross-examination likely, Williams is apt to testify for hours before the prosecution can rest Wednesday, the eighth day of testimony. Any motions, including ones seeking a mistrial on various legal grounds or asking for an acquittal from the judge, would follow before the defense summons any of its own witnesses.

As the state's chief executive, the governor should have a lot more to say about the direction of public education, as one of the state's pre-eminent responsibilities. The best way to accomplish that would be to give the governor authority to appoint the state superintendent of education. Next year would be a good time to advance that idea, with legislative action for a statewide referendum enabling the requisite change in the state constitution. Both Gov. Nikki Haley and state Superintendent Molly Spearman are endorsing the change, and are urging the Legislature to put the question to a vote in the next general election. In a letter to lawmakers this week, they point out that South Carolina is one of only 13 states where the superintendent is an elected official, "wholly separate from the administration of the governor."

Boeing Co. plans to move about 2,500 positions to other sites, cut 500 jobs and close two facilities by the end of 2020 in an effort to make its Defense, Space & Security business more efficient, the company said Tuesday. About 1,600 positions currently in Huntington Beach, California, will move to plants in three other Southern California locations -- El Segundo, Long Beach and Seal Beach. About 500 positions will move to St. Louis County in Missouri, and 400 will shift to Huntsville, Alabama. Chicago-based Boeing will close a plant that employs 290 people in El Paso, Texas, and another that employs 70 people in Newington, Virginia. The company said the moves will reduce facility space by about 4.5 million square feet. The Huntington Beach plant will remain open. Boeing spokesman Ken Smith declined to say how many workers will remain there.

The state's graduation rate, like most nationwide, has been climbing steadily in the past decade. Meanwhile, scores on standardized tests for college and career readiness have flatlined or dropped in some cases.

S.C. education leaders are touting improvements in the state's graduation rate in the latest school report cards, released Tuesday. An attorney for a teen charged with murder told a Richland County jury Tuesday morning that investigators had bungled the case against his client and had no clear evidence proving he shot Zaire Franklin to death in a Columbia area apartment complex last August. "No fingerprints! No DNA! Nothing that tied Jermaine Davis to any murder!" said attorney Dick Harpootlian, ticking off evidence police usually have in murder cases – but not in this one. "They are asking you to jump to conclusions!" Harpootlian said in opening remarks to the four-man, eight-women jury Tuesday at Richland County Courthouse. The case is unusual for several reasons: Harpootlian, a well-known defense attorney, usually only takes murder cases for six-figure fees. Here, he is representing for a nominal fee an indigent youth who has been in and out of S.C. Department of Social Services foster homes for nine years and who was a runaway at the time of the shooting. Prosecutors also allege the killing

happened because of an argument over a paltry amount of money – 17 cents.

The Chester church that owned a bus carrying a Rock Hill football team that crashed in North Carolina in September, killing four people, has denied wrongdoing, claiming the accident was unavoidable and a sudden emergency. However, the lawyer for 21 people injured in the wreck said evidence is "overwhelming" that Sandy River Baptist Church was renting out its bus without regard to safety rules, and has shown neither sympathy or accountability. The church, owner of the bus carrying the Ramah JUCO football team from Rock Hill, wants a lawsuit filed last month in Chester thrown out. The suit was filed by 21 players and coaches that alleged the church failed to properly maintain, service and inspect the bus and its tires. A blown tire led to the bus hitting a guardrail and a bridge, police said. The crash killed four people, including the driver, who was a church member, and injured 39 others. Federal officials have said the bus was not licensed for for-hire service, yet the team chartered the bus.

The threat also mentioned shooting a particular student, an earlier report stated. "Additional responses escalated to the point that several parents had kept their children out of school for fear of this unknown person shooting up the school," officers noted in the report.

No criminal charges have been filed in connection with a controversial display set up in front of Winthrop University's Tillman Hall over the weekend. A white sign taped over the Tillman Hall sign read "Tillman's Legacy." Tillman Hall is named after Benjamin Ryan Tillman, who served as South Carolina governor and as a U.S. senator from 1890 to 1918. A group of artists known as the Association of Artists for Change claimed responsibility for the display, which they said was a work of art designed to bring attention to Tillman's racist history and "disrupt the aesthetic veil the building has."

Anderson County officials moved ahead Tuesday night with a regulation to ban U-47700 and other synthetic opioids, drugs that have contributed to dozens of deaths nationwide in the span of about a year. The move came the day after the U.S. Drug Enforcement Administration put U-47700 on its most restrictive list of controlled substances, calling it a drug that serves no medical purpose and one that poses an imminent threat to public health. Michael Miller, director of the Anderson-Oconee Regional Forensics Lab, confirmed to the Independent Mail on Tuesday that there has been at least one case in Anderson County involving U-47700 in the last three months. Miller declined to discuss specifics, except to say that a person was trying to buy the drug online and that the case remains under investigation.

A Canadian company and BMW supplier is planning to invest \$29 million and create 480 new jobs over four years at a new 230,000-square-foot manufacturing facility at Pacolet Milliken's Tyger Industrial Park North, according to sources. As a small West Virginia community tries to move past the backlash of a racist Facebook post that targeted first lady Michelle Obama, a council member had some inviting words for outsiders who look down on her town. "Come see us," Joyce Gibson said. "Spend a day with us. If I knew you would come, I would bake a cake. We're very decent people." Clay Mayor Beverly Whaling resigned Tuesday and the Town Council later met to accept it. The resignation came after another woman whose post Whaling responded to was placed on leave as director of the nonprofit Clay County Development Corp. The council meeting was brief, with councilman Jason Hubbard reading a statement condemning the "horrible and indecent" post. He apologized on behalf of the town to Michelle Obama and anyone who was offended. "Please don't judge the entire community for one or two individual acts," Hubbard said.

**Associated Press:** Obama tours ancient Greek Acropolis

President Barack Obama toured Greece's most famous ancient monument, the Acropolis citadel, and was due to deliver a speech to the Greek people later Wednesday as he winds up the first leg of his final foreign tour as president and heads from Greece to Germany. Obama entered the complex through the Propylaea, the monumental gateway that serves as an entrance to the site, and walked along the Parthenon temple, which was dedicated to the goddess Athena, considered the patron god of the city of Athens. The U.S. president lingered at the base of the Parthenon, gazing up at the columns and glancing around at the panoramic view of Athens as he chatted with his guide, Eleni Banou of the Culture Ministry's antiquities division. The 5th Century B.C. Parthenon temple is

surrounded these days by scaffolding as part of maintenance works. The entire site was closed to the public for the day for Obama's visit, which has taken place amid draconian security measures that have also banned demonstrations in parts of Athens, and shut down roads and subway stations.

**Associated Press:** Yemen war raises questions of war crimes against civilians

The taxi driver happened by just after a volley of airstrikes hit a highway in western Yemen. The driver, Mohammed al-Khal, stopped, took a wounded ice cream vendor into his car and rushed him to the nearest hospital. But the warplanes were still hunting. Moments after al-Khal pulled up at the hospital in the town of Abs, hell was unleashed. A missile struck just outside the hospital entrance, "like a ball of fire," one witness said. Al-Khal, a father of eight, was incinerated in his car. The blast ripped through patients and family waiting in an outdoor reception area. Nineteen people were killed, along with two civilians killed on the highway. The attack in August typified what has been a pattern in the nearly 2-year-old air campaign by Saudi Arabia and its allies against Yemen's Shiite rebels, known as Houthis. Rights groups and U.N. officials say the U.S.-backed coalition has often either deliberately or recklessly depended on faulty intelligence, failed to distinguish between civilian and military targets and disregarded the likelihood of civilian casualties.
