Dear Commission Members:

Today, I am appointing you to serve on a commission to investigate the facts related to annexing territory, known as Daniel Island, from Berkeley County to Charleston County. I am thankful for your willingness to serve the residents of Daniel Island and the interests of both Berkeley and Charleston counties in this important endeavor.

On November 8, 2013, I was presented with a petition signed by at least ten percent of the registered voters in Daniel Island to annex the property of Daniel Island from Berkeley County to Charleston County. (See enclosed petition and enclosed letter from the South Carolina State Election Commission.) As required by state law, I am appointing four persons, two from the territory proposed to be annexed and two from the other territory of the county from which such territory has been a part; two of these persons may be opponents and two may be advocates of the proposed change of line. (S.C. Code Section 4-5-120) After consulting with legislative delegation members of Berkeley and Charleston Counties and speaking with each of you, my office informs me that you meet the requirements of this statute.

My office has prepared "Information and General Guidelines" regarding the annexation process, due to the statutory requirement that a written report must be provided to the governor for consideration before an election on the question of annexation can be ordered by me. Our office has also enclosed a copy of Article VIII, Section 5 of the South Carolina Constitution and Chapter 5 of Title 4 of the South Carolina Code of Laws, which sets forth the authority for annexation, the duties and responsibilities of this commission, and the annexation process.



Annexation Commission Information and General Guidelines

Prepared by the Office of the Governor

The following information and general guidelines are provided to assist the Annexation Commission in carrying out its duties and responsibilities. The Commission is also advised to carefully review all relevant statutory provisions in carrying out its duties and responsibilities, which can be found in Chapter 5 of Title 4 of the South Carolina Code of Laws.

I. COMMISSION MEMBERS

II. ADMINISTRATIVE MATTERS

A. Proposed Timetable

On or before December 31, 2013, the Commission is requested to present a proposed timetable to the Governor regarding a schedule of dates for her review. The timetable is expected to include a date for an initial organizational meeting, dates for additional meetings and deadlines, and a date for the issuance of the report, all of which is expected to be completed no later than April 30, 2014. The initial organizational meeting is recommended to be held as soon as practicable, taking into account the importance of this issue by all interested parties. In all matters, the Commission should commit to fulfilling its obligations both expeditiously and thoroughly, bearing in mind that a timely resolution to this issue is in the public's best interest.

B. Costs

Pursuant to Section 4-5-120, the petitioners have deposited \$25,000.00 with the Berkeley County Clerk of Court to cover all costs of the (1) surveys and plats; (2) commission; and (3) election. The Commission shall record a full accounting of all funds spent in the Commission's report to the Governor. (See enclosed letter from the Berkeley County Clerk of Court.)

C. Open Meetings and Open Records Requirements

Pursuant to Section 30-4-20(a), the Commission appears to constitute a public body under the Freedom of Information Act. Accordingly, in the interest of transparency, meetings of the Commission should be open to the public. The Commission is asked to review the open meetings and records laws found in Chapter 4 of Title 30 and seek the opinion of counsel should any questions arise regarding compliance with the Freedom of Information Act.

III. CONTENTS OF THE REPORT

Pursuant to Section 4-5-160, the Commission shall investigate all facts relating to annexing Daniel Island from Berkeley County to Charleston County and shall report in writing these facts and all such relevant matters as the Governor may direct for her information. Accordingly, the Commission's report shall include, but shall not be limited to, facts and information relating to the following:

- (1) The area of the proposed territory to be annexed and that remaining;
- (2) The population of the proposed territory to be annexed and that remaining;
- (3) The assessed property values of the proposed territory to be annexed and that remaining;
- (4) The proximity of the line to any courthouse;
- (5) The proper amount of indebtedness of the county losing area to be assessed to the county gaining such area;
- (6) Other matters deemed relevant or necessary to understanding the effects of the proposed annexation for all interested parties; and
- (7) An itemized statement of the expense of the survey and plats and a full accounting of all funds spent.

In addition to the above items, the Commission is asked to include in its report an explanation of how all statutory requirements of the Commission have been fulfilled.

IV. ADDITIONAL INFORMATION

Should the Commission have difficulty obtaining information in the possession of a state or local government entity needed in the course of the Commission's investigation, it is encouraged to contact the Governor's Office to assist in requesting that information. Furthermore, any information that the Governor's Office receives related to the annexation process will be immediately forwarded to the Commission. SOUTH CAROLINA CONSTITUTION

ARTICLE VIII.

LOCAL GOVERNMENT

SECTION 4. Merger of counties.

The General Assembly shall provide by law for the merger of adjoining counties. Such mergers shall be permitted by the General Assembly only upon the request of the governing bodies of the counties or upon petition by ten percent of the registered voters in each of the counties involved. No merger shall take place unless a majority of the electors voting on the question shall vote therefor in each of the counties. (1972 (57) 3184; 1973 (58) 67.)

SECTION 5. Merger of parts of counties with adjoining counties.

The General Assembly shall provide for the merger of a part or parts of a county with one or more adjoining counties upon request by the governing body of the county in which such part or parts are located, or upon petition by ten percent of the registered voters in the area desiring to transfer to another county. No merger shall take place unless two thirds of the qualified electors voting on the question in the territory to be transferred and a majority of the electors voting on the question in the county to which the territory is proposed to be annexed shall vote therefor. (1972 (57) 3184; 1973 (58) 67.)

SOUTH CAROLINA CODE OF LAWS

CHAPTER 5.

CHANGE OF BOUNDARIES

SECTION 4-5-120. Procedure for annexing part of a county.

Whenever the governing body of a county by resolution requests that a part of such county be merged with one or more adjoining counties or whenever ten percent of the registered voters in an area of one county petition in writing that such area be transferred to another county, the county governing body or the petitioners, as the case may be, shall deposit with the clerk of court of such county an amount of money sufficient to cover the expenses of surveys and plats and of the annexation commission and the election to be held to determine whether the proposed annexation shall be effected and shall file such resolution or petition in the office of the clerk of court of such county and transmit the petition or resolution to the Governor.

HISTORY: 1976 Act No. 697 Section 1.

SECTION 4-5-130. Appointment of commission for annexation.

When a request of a county governing body or a petition as prescribed in Section 4-5-120 has been presented to the Governor for changing the boundary line or lines between two counties, whereby a portion of the territory of one county would be annexed to another, the Governor shall within thirty days appoint a commission of four persons, two from the territory proposed to be annexed and two from the other territory of the county or counties from which such territory has theretofore been a part. Two of the persons, if such are to be found, shall be opponents and two advocates of the proposed change of line.

HISTORY: 1976 Act No. 697 Section 2.

SECTION 4-5-140. Employment of surveyors to survey line; marking line on land.

The commission may contract for the survey and location of the proposed change of line and for such purpose may employ three competent disinterested surveyors, who are nonresidents of the counties affected, two to be selected by the commission and the third by the two selected by the commission. Such surveyors shall clearly mark the proposed change of line upon the land with due regard to all legal provisions and limitations and certify plats showing such line.

HISTORY: 1976 Act No. 697 Section 3.

SECTION 4-5-150. Filing of plats; deposit of money to cover expenses.

Certified plats of such line shall be filed with the Secretary of State and with the respective clerks of court of each county affected thereby and a deposit of an amount of money sufficient to cover expenses of survey and plats and other necessary expenses including advertising shall be made with the treasurer of the county whose territory is proposed to be reduced by those requesting or petitioning for the change of line.

HISTORY: 1976 Act No. 697 Section 4.

SECTION 4-5-160. Commission shall report all relevant facts.

The commission shall carefully investigate all facts relating to the area, population and assessed property values of the territory proposed to be severed and that remaining, the proximity of the line to any courthouse and the proper amount of indebtedness of the county losing area to be assessed to the county gaining such area and shall report in writing to the Governor upon all such relevant matters as the Governor may direct for his information. The commission shall also report to the Governor an itemized statement of the expense of the survey and plats.

HISTORY: 1976 Act No. 697 Section 5.

SECTION 4-5-170. Governor shall order election; voting place; eligible electors.

(A) Upon satisfactory compliance with Sections 4-5-120 to 4-5-160, the Governor shall order an election to be held in an area sought to be transferred and an election to be held in the county to which the area is proposed to be transferred. If there is no established voting place in the area proposed to be transferred, the Governor in his order of election shall designate the place or places at which the voters in the area shall vote. All qualified electors of the area proposed to be annexed and the county to which the area is proposed to be annexed are eligible to vote in the elections.

(B) Where the area proposed to be annexed is less than fifty acres in size and is titled in the name of ten or fewer freeholders as defined in Section 5-3-240 and upon satisfactory compliance with Sections 4-5-120 through 4-5-160, the Governor shall order the county board of elections in the county in which the area proposed to be annexed is located to canvass the qualified electors residing in the area as to whether the area proposed to be annexed should be transferred to the annexing county. Notice of the canvassing must be given to the qualified electors residing in the area proposed to be annexed by certified mail. The canvassing of the qualified electors must be in the form of a census taken by the county board of elections on the third Tuesday after the notice is given or attempted. If the county commission of elections certifies that two-thirds of the qualified electors in the area proposed to be annexed favor annexation, the governing body of the county to which the area is proposed to be transferred, upon the concurring vote of the governing body of the county from which the area is proposed to be transferred, may vote to require the General Assembly to ratify the transfer of property under Section 4-5-220.

HISTORY: 1976 Act No. 697 Section 6; 1988 Act No. 520, eff May 18, 1988.

SECTION 4-5-180. Conduct of elections.

Except as provided in Section 4-5-170(B), the elections called for must be conducted at the time specified in the Governor's order by the respective election commissions of the two counties in accordance with the applicable constitutional and statutory provisions relating to elections.

HISTORY: 1976 Act No. 697 Section 7; 1988 Act No. 520, eff May 18, 1988.

SECTION 4-5-190. Election results; canvass of returns in annexed area.

Except as provided for in Section 4-5-170(B), the commissioners of elections for the county from which the area is proposed to be transferred shall canvass the returns of the managers of each precinct in the area seeking annexation in their county as the returns are canvassed in general elections and shall certify the results of the canvassing in a tabulated statement of the vote at each precinct to the Secretary of State who shall transmit a tabulated statement of the vote at each precinct of the county to the Senate and House of Representatives at its next session.

HISTORY: 1976 Act No. 697 Section 8; 1988 Act No. 520, eff May 18, 1988.

SECTION 4-5-200. Election results; canvass of returns in annexing area.

Except as provided in Section 4-5-170(B), the commissioners of election for the county to which the area is proposed to be transferred shall canvass the returns of the managers of each voting place in the county as the returns are canvassed in the general elections and shall certify the results of the canvass in a tabulated statement of the vote at each polling place to the Secretary of State who shall transmit a tabulated statement of the vote at each polling place to the General Assembly for action as provided for in Section 4-5-220.

HISTORY: 1976 Act No. 697 Section 9; 1988 Act No. 520, eff May 18, 1988.

SECTION 4-5-210. Protests or contests; appeals.

The commissioners of election respectively as judicial officers shall decide all cases of protest or contest in the areas of their jurisdiction that may arise in such elections and their decisions shall be final and conclusive evidence of the result of the elections unless appealed from within five days to the Court of Common Pleas of the county in which the election was held.

HISTORY: 1976 Act No. 697 Section 10.

SECTION 4-5-220. Alteration of county line or lines by General Assembly.

The General Assembly upon receipt of the certified returns shall as soon as practicable alter the county line or lines in accordance with the request or petition if two-thirds of the qualified electors voting or otherwise indicating their preference, under Section 4-5-170(B), on the question in the area to be transferred vote or otherwise indicate, under Section 4-5-170(B), in favor of the transfer and if a majority of the qualified electors voting in the county to which the transfer is proposed or the members of the county governing boards, under Section 4-5-170(B), vote in favor of the transfer, provided that all the constitutional requirements for the alteration of county lines have been complied with, all of which must be determined by the General Assembly. The annexation must then become effective.

SECTION 4-5-230. Payment of costs by annexing county; special tax.

When one portion of a county is annexed to another county, the county to which it is annexed shall levy a special tax upon all property in such annexed area to cover the cost of survey and transfer or so much thereof as the governing body of the county to which the annexation or addition is made shall deem just and proper, and such governing body may levy upon the property within the original lines of their county such tax as in their judgment shall seem just and fair to augment the amount raised by taxation within the annexed area to reimburse and refund those who made the deposit as provided in Section 4-5-120 for the cost of annexation.

HISTORY: 1976 Act No. 697 Section 12.

SECTION 4-5-240. Compensation and expenses of commissioners.

The commissioners appointed by the Governor in accordance with Section 4-5-130 shall each be entitled as compensation for services to twenty-five dollars per day for not exceeding five days and necessary traveling expenses to be voted and paid as expenses of survey. Upon filing of their report and certified plats as herein required, the commissioners may draw their warrant upon the county treasurer

with whom deposit has been made as herein required for payment of the expenses of survey and a warrant shall be payable only out of such deposit.

HISTORY: 1976 Act No. 697 Section 13.

SECTION 4-5-250. Subsequent election after defeat of proposal.

Upon the defeat of any proposed change of boundary line of a county at any election thereon, no election upon the same or any modified change of such boundary line shall be held within four years thereafter.

HISTORY: 1976 Act No. 697 Section 14.

SECTION 4-5-260. State aid to subdivisions for county government; allocation formula for annexed county.

With respect to state aid to subdivisions for county government and the allocation formula for an annexed county, where a portion of one county is annexed to another county, the total amount allocated to the two counties shall not exceed the total which would be allocated to the two counties separately. However, the population of the annexed areas must be taken into consideration in determining the proportionate share of the total allocation due to each county.



Petition in Support of Annexation of Property from Berkeley County to Charleston County

Pursuant to Article VIII, section 5 of the Constitution of the State of South Carolina and section 4-5-120 of the South Carolina Code, the undersigned registered voters residing within the area described below (the "Property") hereby petition for the transfer and annexation of the Property from Berkeley County, South Carolina, to Charleston County, South Carolina; that the Governor appoint an annexation commission under section 4-5-130 of the South Carolina Code to investigate and report on all relevant facts relating to the annexation; that the Daniel Island Town Association, on behalf of the undersigned, deposit an amount of money with the Clerk of Court for Berkeley County, South Carolina, sufficient to cover the expenses of the surveys, annexation commission, and the election; and that, pursuant to section 4-5-170(A) of the South Carolina Code, the Governor order elections to be held to determine whether the proposed annexation shall be effected.

The area to be annexed is described as follows:

All those certain pieces, parcels or tracts of land and other areas situate, lying and being in Berkeley County, South Carolina, being bounded on the north by Clouter Creek, Beresford Creek, and Ralston Creek (also known as Nobels Creek); on the east by Ralston Creek (also known as Nobels Creek) and the center line of the Wando River; on the south by the center line of the Wando River and the center line of the Cooper River, including the point where the center line of the Wando River intersects the center line of the Cooper River as shown on the National Oceanic and Atmospheric Administration, National Ocean Survey chart 11524, 38th edition, dated March 23, 1991; and on the west by the center line of the Cooper River, Clouter Creek, and Beresford Creek; as shown on the plat attached hereto and incorporated herein by reference as Exhibit A; with said property to include but not be limited to the following tracts:

Tract 1

All of those certain pieces, parcels or tracts of land comprising the area commonly known as Daniel Island, situate, lying and being in Berkeley County, South Carolina, containing 3,836 acres, more or less, and being bounded on the east by the Wando River, on the south by the Wando River and the Cooper River, on the west by the Cooper River, and on the north by Beresford Creek and Ralston Creek, together with all adjacent marshes and lands lying below the mean high water mark of abutting tidal waters.

Tract 2

All of those certain pieces, parcels or tracts of land situate, lying and being on or adjacent to Daniel Island in Berkeley County, in Charleston Harbor, bounded by the low water mark of the Cooper River on the west, by the low water mark of the Wando River on the east, by the high lands of Daniel Island on the north, and by the low water mark of the confluence of the said Cooper River and the Wando River to the south, shown on the plat recorded in the Berkeley County RMC Office in Plat Book T, Page 70 as lying generally within the letters A-B-C-D-E-F-G-A, and including the "Old Spoil Area," the "New Spoil Area," and the tidelands to the low water mark whether yet filled or not lying within the area designated by those letters, and being to the south of the points A and F on the two sides of the said Island.

Tract 3

All those submerged lands and other areas butting and bounding as follows: To the north by the high lands of Daniel Island; to the east and southeast by a straight line running south from the high lands of Daniel Island on the western bank of the southeast end of Ralston Creek to the center line of the Wando River and from this point running approximately southwest along the center line of the

Wando River to its intersection with the center line of the Cooper River as shown on the National Oceanic and Atmospheric Administration, National Ocean Survey chart 11524, 38th edition, dated March 23, 1991; and to the southwest and west from this point running approximately northwest along the center line of the Cooper River to a point where the center line of the Cooper River intersects a straight line running south from the high lands of Daniel Island on the eastern bank of the southwest end of Clouter Creek to the center line of the Cooper River.

Tract 4

All those certain pieces, parcels or tracts of land situate, lying and being in the City of Charleston, Berkeley County, South Carolina, commonly known as Rhoden Island, containing in the aggregate 325 acres of highland, more or less, and 665 acres of marshland, more or less, and butting and bounding as follows: To the north on Beresford Creek; to the east on Beresford Creek and a portion of said creek known as Nowell Creek (a/k/a Nobels Creek); to the south on the Wando River; and to the west on Ralston Creek and a straight line connecting the northern end of Ralston Creek and Beresford Creek, which line runs approximately north, all as more particularly shown on a plat showing a part of Daniel Island and Rhoden Island dated October 15, 1955, prepared by Woodrow W. 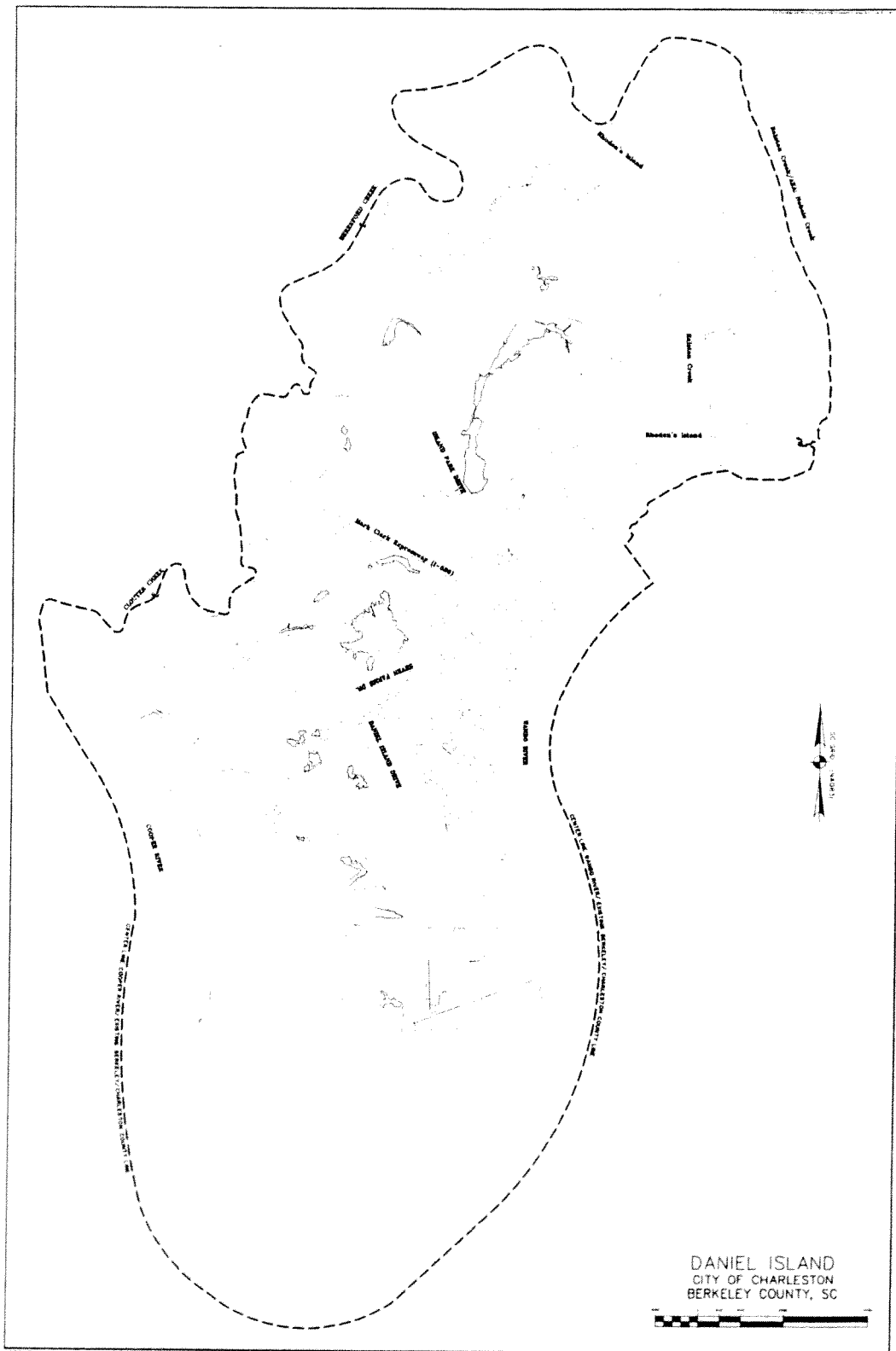
