Mr. Poore called the meeting to order and Councilman Samuel S. Gerrard gave the invocation.

On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to approve the minutes of the April 1, 1980 and April 8, 1980 meetings as mailed.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adopt Resolution #108 Vehicle Safety.

On the motion of Mr. Gerrard, seconded by Mr. Wiles, Council voted unanimously to adopt on third and final reading Ordinance #47 (Mayfair Mills).

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to adopt Ordinance #48 (Anderson County Recreation Commission) with one change. This change would be each Councilmember would appoint 3 members instead of 2 from his district. This Ordinance was adopted on third and final reading.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adopt Ordinance #51 (Master In Equity Office) on second reading.

Mr. Bates from West Pelzer TV addressed Council concerning an Ordinance to serve West Pelzer, Pelzer, Piedmont & Powdersville with cable television. Mr. Grady Ireland gave a brief synopsis of Fort Hill Cable TV Company. Mr. Poore advised them that he would receive as information due to the fact that one of the Council members was out attending camp and would prefer to wait until all members are present.

Mrs. Jean Martin, Program Coordinator for Anderson County Association for Retarded Citizens, addressed Council asking for a Resolution naming their association as an entity in Anderson County to provide transportation to the mentally retarded. On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to adopt Resolution #109.

Members of the newly formed Anderson County Wrecker & Towing Association asked the County Council to establish ordinances barring wreckers from running wrecks or soliciting on the highways. County Attorney Robert P. Lusk said the Council had no authority to establish wrecker-service rules on state highways. Attorney Ronnie Cole, representing Mr. Harold Beebe, stated that Mr. Beebe would consider legal action against anyone making undocumented claims that he offered kickbacks to highway patrolman. Council received as information.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adjourn at 7:45 p.m.
