### PROCEDURE CODES

The S.C. Medicaid program requires that claims be submitted using the correct procedure code for the service rendered. The following is a list of procedure codes for Children's Behavioral Health Services:

## SECTION 4 PROCEDURE CODES

### PROCEDURE CODES (CONT'D.)

Procedure codes for state agencies and school districts may differ from those listed above. These providers should refer to their Medicaid contract or contact the appropriate program manager for further information on procedure codes.

### V-CODES

V-codes are used to identify encounters with the health care setting for reasons other than illness or injury. The use of a V-code may be appropriate when, for example, there is insufficient information to determine whether or not a presenting problem is attributable to a mental disorder, (*e.g.*, academic problem, antisocial behavior, etc.).

The ICD-9-CM indicates that V-codes fall into one of three categories: problems, services, or factual. A problem V-code would only be used when the problem has a potential effect on the patient's current diagnosis. A factual V-code is used to supply additional information regarding an established diagnosis.

For the purposes of Children's Behavioral Health Services, the following V-codes may be used:

<b>V61.20</b>	Parent-child relational problem
<b>V61.21</b>	Neglect/abuse of child
<b>V61.9</b>	Relational problem related to a mental disorder
<b>V62.81</b>	Interpersonal problems, not elsewhere classified
<b>V62.82</b>	Bereavement
<b>V71.02</b>	Child or adolescent antisocial behavior
