Re: *Proposed Roundabout Intersection at S-22 (Market Street) Intersection with Monroe Street and Southwood Street, Anderson County, SCDOT PIN P042365*

Dear Dr. Daggett:

The South Carolina Department of Transportation (SCDOT) proposes to replace the current offset intersection of S-22 (Market Street), Monroe Street, and Southwood Street with a roundabout intersection. Archaeological investigations for the project resulted in the identification of no archaeological sites. Aboveground investigations identified twelve (12) sites (#s 1469—1480). Six (6) of these resources (site #s 1474-1479) contribute to a recommended National Register of Historic Places (NRHP)-eligible Westside Historic District that has eligible boundaries corresponding to a locally designated historic district of the same name (see attached report for district boundaries). The remaining resources are recommended as ineligible for the NRHP.

The proposed project will occur at the edge of the Westside Historic District and will not directly impact any contributing resources beyond small takes of right-of-way at sites # 1475, 1476, 1478 and 1479. These right-of-way takes will not significantly alter the character, setting, or feel of these contributing resources. Additionally, the proposed roundabout will not dramatically alter the street pattern or layout of the district nor will it alter the character, setting, or feel of the district. It is therefore recommended that the proposed project will have no adverse effect to historic resources. No additional investigations are recommended.

In accordance with the memorandum of agreement approved by the Federal Highway Administration (FHWA), November 29, 2011, SCDOT is providing this information as agency official designee, as defined under 36 CFR 800.2, to ensure compliance with Section 106 of the National Historic Preservation Act.

It is requested that you review the enclosed material and, if appropriate, indicate your concurrence with SCDOT findings, thus completing the Section 106 consultation process. Please respond within 30 days if you have any objections or if you have need of additional information.

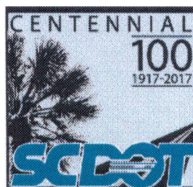
