**Subject:** Update on CMS State-only calls on new managed care regulation

Good Afternoon NASUAD Members –

Since Damon's email last week, CMS has modified the schedule of all-state calls slightly; most significantly, the call to explain the MLTSS requirements has been moved up from **June 29th to next Wednesday, June 17th**.

These calls are targeted for state officials, so please do not forward to providers, health plans or advocacy groups.
