One year after the devastating fire on Front Street in Georgetown, most of the businesses destroyed in the fire have reopened in other locations. But the 700 block of the street is still nothing more than weeds and fire debris.

Note: Governor Nikki Haley promised a million dollars to help Front Street rebuild.

The flames were being driven by a stiff wind from the southeast, the worst possible weather scenario, Scoville said. With dawn the wind abated, and fire trucks and manpower arrived from Midway, Murrells Inlet-Garden City, Andrews and from as far away as Kingstree.

Note: Seven buildings were destroyed, and Gov. Nikki Haley called on South Carolina residents to contribute to a fund to assist the displaced when she surveyed the damage the day after the fire. Gifts surpassed \$210,000, and a group of volunteers disbursed the money directly to fire victims.

South Carolina's newest political party says voters should be able to recall politicians who violate the public's trust, whether through illegal activity or embarrassing the state. American Party Chairman Jim Rex said Thursday it's time to give voters the option of recall elections to discipline politicians who won't police themselves.

Note: In 2012, former Lt. Gov. Ken Ard resigned and pleaded guilty to campaign-spending violations, while Gov. Nikki Haley was cleared by the House Ethics Committee of allegations she illegally lobbied for two employers while in the House. Since then, at least three current House members have been convicted of misdemeanors and three others face charges. Only felony convictions automatically remove someone from office.

Lexington Medical Center has been ordered to shut down an open heart surgery unit and a catheterization lab it opened earlier this year when a long-standing state approval process was in limbo. The State newspaper reported (<http://bit.ly/1rvvvRz>) Administrative Judge Ralph King Anderson III ruled this week the hospital needed a state-issued certificate of need for the facilities.

Note: The state program was in limbo when Gov. Nikki Haley vetoed its funding. But the South Carolina Supreme Court ruled in April only the General Assembly could end the program.

The number of people seeking U.S. unemployment benefits increased last week after falling sharply two weeks ago. Despite the rise, the level of applications remains near pre-recession levels, a sign that hiring will likely remain healthy.
